MINERAL RESOURCES REGULATION 1990

[as amended by all amendments that commenced on or before 2 January 1998]

PART 1—PRELIMINARY

Short title

1. This regulation may be cited as the *Mineral Resources Regulation* 1990.

Definitions

- 2. In this regulation—
- **"average market price"**, for a mineral, means the average settlement price for the mineral over a royalty period on—
 - (a) for gold or silver—the London Bullion Market; or
 - (b) for copper, lead or zinc—the London Metal Exchange.
- "designated fossicking land" has the meaning given by the *Fossicking* Act 1994.
- "plan", in relation to a restricted area, means a plan held in the office of the department.
- **"reference price"**, for copper, gold, lead, silver or zinc—see schedule 1, section 4.
- "reference price 1"—see schedule 1, section 4.
- "reference price 2"—see schedule 1, section 4.
- "reference price 3"—see schedule 1, section 4.
- **"royalty base rate"**, for copper, gold, lead, silver or zinc—see schedule 1, section 5.
- "royalty period" means—
 - (a) the financial year covered by a royalty return; or

(b) if the Minister has approved a different year for a royalty return—the year approved by the Minister.

"yearly rental" means the amount of rent payable for a calendar year.

Meaning of "block identification map"

3. A **"block identification map"** is a map that forms part of the series of 17 maps known as 'Block Identification Map—Series B' held in the office of the department.

Meaning of "restricted area"

4. A **"restricted area"** is the land included in an area specified by schedule 4, part 2 to be a restricted area.

Naming convention for restricted areas

5. In this regulation, the portion of schedule 4, part 2 that relates to a particular restricted area may be referred to by the same designation as the restricted area.

Example—

The portion of schedule 4, part 2 of relating to Restricted Area 1 may be referred to as 'Restricted Area 1'.

Forms

6.(1) The prescribed forms for the purposes of the Act are the forms approved by the Minister.

(2) A person may request the chief executive to give the person a document setting out a form approved under subsection (1).

(3) The chief executive must promptly comply with a request under subsection (2).

Fees

7.(1) The fees set out in schedule 2 are the prescribed fees to be paid for

the purposes specified in that schedule.

(2) The chief executive or a mining registrar is not to record any action or dealing for which a fee is prescribed until payment of that fee is made.

PART 2-MINING DISTRICTS

Mining districts

8.(1) The land included in each part of schedule 5 is a mining district.

(2) Each mining district is assigned the name stated in the part heading.

PART 3—PROSPECTING PERMITS

Conditions of prospecting permit

9. For the purposes of section 25 of the Act the prescribed conditions of a prospecting permit are that the holder of the prospecting permit and all persons acting under the authority of the permit—

- (a) are to use existing roads or tracks on occupied land where practicable to do so;
- (b) are to take every precaution to ensure there is no dispersal of parthenium weed seed or the seed of any other declared plant within the meaning of the *Rural Lands Protection Act 1985* as a result of activities carried on under the authority of the permit;
- (c) are to gain access to occupied land only at a point or points designated by a mining registrar unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar;
- (d) are to restrain animals in the custody of that person or those persons on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with

the mining registrar;

- (e) are not to discharge a firearm on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar;
- (f) are not to light open fires unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar.
- (g) for unoccupied land—must ensure rubbish and human waste is disposed of in a safe and sanitary way.

Register of prospecting permits

10.(1) A mining registrar must record the following particulars of each application for a prospecting permit and each prospecting permit in the register—

- (a) name of holder;
- (b) address for service of notices on the holder;
- (c) number of the permit;
- (d) category of the permit;
- (e) date of application for the permit;
- (f) date of grant of the permit or rejection of application for the permit;
- (g) date of commencement of the permit;
- (h) date of expiry, cancellation or surrender of the permit;
- (i) security required under section 26 of the Act;
- (j) description of land comprised in the permit and access to that land;
- (k) any special conditions upon which the permit is granted;
- (l) consents.

(2) The register may be searched only by the owner of the land during the hours prescribed for the conduct of business at the office of the mining registrar on payment of the prescribed fee.

(3) The register may be maintained manually, on computer disc or in such other form as may be adopted by direction from the chief executive.

Security for prospecting permits

11. The amount of security a mining registrar fixes for a district prospecting permit must not be less than \$1 000.

PART 4—MINING CLAIMS

Conditions of mining claim

12. For the purposes of section 81 of the Act the prescribed conditions of a mining claim are that the holder and all persons acting under the authority of the mining claim—

- (a) are to ensure there is no dispersal of parthenium weed seed or the seed of any other declared plant within the meaning of the *Rural Lands Protection Act 1985* as a result of mining activities or as a result of access to the area of the claim;
- (b) are to restrain animals in the custody of that person on the land comprised in the claim unless the area of the claim is fenced in such a manner as to contain those animals;
- (c) are not to discharge a firearm on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar.

Register of mining claims

13.(1) A mining registrar must record the following particulars of each application for a mining claim and each mining claim in the register—

- (a) name of each holder and interest held;
- (b) name and address of 1 person for service of notices on the holder;
- (c) name of mining claim;

- (d) number of mining claim;
- (e) mining district in which the land the subject of the mining claim is situated;
- (f) locality;
- (g) date and time of marking out;
- (h) date and time of application;
- (i) date certificate of application issued;
- (j) date of grant of mining claim or abandonment or rejection of application;
- (k) term;
- (l) renewals;
- (m) date of expiry, cancellation or surrender;
- (n) area;
- (o) local government;
- (p) caveats;
- (q) warrants of execution;
- (r) annual rental;
- (s) security required under section 83 of the Act;
- (t) minerals sought.

(2) The register may be searched during the hours prescribed for the conduct of business at the office of the mining registrar on payment of the prescribed fee.

(3) The register may be maintained manually, on computer disc or in such other form as may be adopted by direction from the chief executive.

Request for registration of execution

14.(1) A request for registration of an execution of the interest of a holder of a mining claim is to be made to the mining registrar in the approved form and is to be accompanied by—

(a) an office copy or a certified copy of the execution evidencing the

authority to seize and sell the interest; and

(b) the prescribed fee.

(2) The assignment of the interest pursuant to registration of an execution is to be in the approved form and is to be accompanied by the prescribed assignment fee.

Excavations near railway land

15.(1) The holder of or applicant for a mining claim is not to make any excavation within a distance of 12 m in a horizontal direction or of 15 m in a vertical direction from any embankment, cutting, bridge, pier, culvert, drain or other work on a railway line passing over or near to the land comprised in the mining claim or application without the authority in writing of the chief executive of Queensland Rail.

Maximum penalty-200 penalty units.

(2) The request for the authority of the chief executive of Queensland Rail is to be made in the first instance to the chief executive.

Moving datum post after survey of contiguous land

16.(1) Where the land the subject of an application for a mining claim is shown in the application as being contiguous with other land which is the subject of—

- (a) a mining claim; or
- (b) a mining lease; or
- (c) an application for a mining claim; or
- (d) an application for a mining lease;

and that other land is not surveyed, then, within 14 days (or such longer period as the Minister in the particular case allows) after the mining registrar has notified the applicant for the mining claim in writing that a survey of that other land has been completed and that all survey marks defining the boundary of the other land have been placed, the applicant for the first mentioned mining claim may adjust the marking out of the land so that the land applied for is still contiguous with that other land as surveyed and may be surveyed accordingly. (2) Subsection (1) does not authorise the adjustment of the marking out of any land so as to include land which was not land to which the applicant's prospecting permit applied at the date of application for the mining claim, or the surveying of that land.

(3) When the marking out of the land comprised in the application has been adjusted or the land has been surveyed, the land is to be the land marked out and applied for by the applicant pursuant to the provisions of the Act.

Instrument of mortgage

17. A mining registrar is not to record particulars of a mortgage over a mining claim unless 2 copies of the executed instrument of mortgage are lodged with the mining registrar in the approved form and accompanied by the prescribed fee.

Sale by mortgagee

18.(1) When a mortgagee exercises a power of sale contained or implied in a mortgage over a mining claim the mortgagee is to—

- (a) furnish the mining registrar with satisfactory evidence that the power of sale has been properly exercised; and
- (b) submit the assignment of the interest pursuant to the exercise of the power of sale in accordance with the provisions of section 96 of the Act; and
- (c) pay the prescribed assignment fee.

(2) An assignment by a mortgagee exercising a power of sale under a mortgage over a mining claim is to be made in the approved form and is to be accompanied by—

- (a) a copy of the government gazette and of a newspaper circulated in the locality, containing the notice of the mortgagee's intention to sell; and
- (b) the certificate of grant of the mining claim; and
- (c) the duplicate of the mortgage under which the sale was made.

Rental payable on a mining claim

19. The yearly rental payable on a mining claim is prescribed in schedule 3.

Area of mining claim land

20. The area of a mining claim over specified land in a mining district specified in schedule 6 must not be more than the area specified for the land in schedule 6.

Permitted equipment and prohibited machinery on mining claims

21.(1) The following equipment may be used for prospecting or hand mining on land in a mining claim—

- (a) a pick, shovel, hammer, gad or sieve;
- (b) powered machinery that is not prohibited machinery.

(2) Prohibited machinery must not be used for prospecting or hand mining on land in a mining claim.

(3) Prohibited machinery may only be used to—

- (a) transport—
 - (i) mineral bearing ore or wash; or
 - (ii) equipment (including machinery), materials or water, that is used in connection with mining operations; or
- (b) build storage facilities for water that is used in connection with mining operations; or
- (c) rehabilitate the surface area of land in a mining claim.
- (4) In this section—

"powered machinery"-

- (a) means a mechanical device powered by air, electricity, gas, internal combustion, steam or water; and
- (b) includes the following—
 - (i) a classifier, compressor, drier, drill (other than a vehicle

mounted drill), elevator, feeder, filter, hoist, jack-pick, puddler, pulsator, pump, separator, shaker, shute, trommel, vibrator, willoughby, winch and windlass;

- (ii) for land within the Mareeba mining district—an eductor dredge that—
 - (A) has a maximum inlet nozzle diameter of 200 mm; and
 - (B) is used when water flows in the Palmer river, Mitchell river or their tributaries;
- (iii) for land in restricted area 25 within the Quilpie mining district—
 - (A) a vehicle mounted drill with a maximum diameter of 25 cms used for exploration drilling; and
 - (B) a vehicle mounted drill with a maximum diameter of 1 m used for drilling access shafts.

"prohibited machinery" means any of the following powered machinery—

- (a) a backhoe, bobcat, bucket excavator, bulldozer, clamshell, continuous miner, dragline, dredge, end-loader, excavator, grader, loader, ripper, rooter, scarifier, scoop, scoopmobile, scraper, tractor or traxcavator;
- (b) a cart, crane, locomotive, monorail, motor vehicle (with or without a trailer) or ropeway.

PART 5—EXPLORATION PERMITS

Conditions of exploration permit

23. For the purposes of section 141 of the Act the prescribed conditions of an exploration permit are that the holder of an exploration permit and all persons acting under the authority of the permit—

(a) are to use existing roads or tracks on occupied land where practicable to do so;

- (b) are to take every precaution to ensure there is no dispersal of parthenium weed seed or the seed of any other declared plant within the meaning of the *Rural Lands Protection Act 1985* as a result of activities carried on under the authority of the permit;
- (c) are to gain access to occupied land only at a point or points designated by the mining registrar unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive;
- (d) are to restrain animals in the custody of that person or those persons on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive;
- (e) are not to discharge a firearm on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive;
- (f) are not to light open fires unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive.

Register of exploration permits

24.(1) The chief executive must record the following particulars of each application for an exploration permit and each exploration permit in the register—

- (a) name of each holder and interest held;
- (b) name and address of 1 person for service of notices on the holder;
- (c) number of the permit;
- (d) mining district in which land over which the permit is granted or sought is situated;
- (e) locality;

- (f) date of application for the permit;
- (g) date of grant of the permit or abandonment or rejection of application;
- (h) date of commencement of the permit;
- (i) term;
- (j) area and reductions;
- (k) renewals;
- (1) date of expiry, cancellation or surrender of the permit;
- (m) annual rental;
- (n) security required pursuant to section 144 of the Act;
- (o) caveats;
- (p) consents.

(2) The register may be searched during the hours prescribed for the conduct of business at the office of the mining registrar for the mining district of Brisbane on payment of the prescribed fee.

(3) The register may be maintained manually, on computer disc or in such other form as may be adopted by the chief executive.

Land subject to exploration permit

25. For the purposes of section 127(4) of the Act, the area prescribed is—

- (a) in respect of coal—300 sub-blocks; and
- (b) for all minerals other than coal—100 sub-blocks.

Application for exploration permit

26.(1) For the purposes of section 133(f) of the Act the office prescribed for the receipt of applications for exploration permits is any office of a mining registrar.

(2) Where a mining registrar refuses to accept the lodgment of a document as an application for an exploration permit the mining registrar is

to retain a copy of the document and inform the person lodging the document that the lodgment has not been accepted and of the reasons therefor.

Numbering of application

27.(1) The mining registrar is to allocate to each application for the grant of an exploration permit the next available number by reference to the last number allocated to an exploration permit or application for an exploration permit of that type recorded in the register maintained by the chief executive.

(2) The number allocated to an exploration permit is to include identification of the type of exploration permit by reference to coal or mineral other than coal or specified minerals the subject of the permit by a consistent method approved by the chief executive.

Rental payable on exploration permit

28. The rental payable on an exploration permit is prescribed in schedule 3.

PART 6-MINERAL DEVELOPMENT LICENCES

Conditions of mineral development licence

29. For the purposes of section 194 of the Act the prescribed conditions of a mineral development licence are that the holder of the mineral development licence and all persons acting under the authority of the licence—

- (a) are to use existing roads or tracks on occupied land where practicable to do so;
- (b) are to take every precaution to ensure there is no dispersal of parthenium weed seed or the seed of any other declared plant within the meaning of the *Rural Lands Protection Act 1985* as a result of activities carried on under the authority of the licence;

- (c) are to gain access to occupied land only by the access approved by the Minister;
- (d) are to restrain animals in the custody of that person or those persons on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive;
- (e) are not to discharge a firearm on occupied land unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive;
- (f) are not to light open fires unless the holder has obtained the consent in writing of the owner and has lodged that consent with the mining registrar and forwarded a copy of that consent to the chief executive.

Register of mineral development licences

30.(1) The chief executive must record the following particulars of each application for a mineral development licence and each mineral development licence in the register—

- (a) name of each holder and interest held;
- (b) name and address of 1 person for service of notices on the holder;
- (c) number of mineral development licence;
- (d) mining district in which the land the subject of the mineral development licence is situated;
- (e) locality;
- (f) date and time of application;
- (g) date of grant of mineral development licence or abandonment or rejection of application;
- (h) date of commencement;
- (i) term;
- (j) renewals;

- (k) date of expiry, cancellation or surrender;
- (l) area;
- (m) caveats;
- (n) warrants of execution;
- (o) annual rental;
- (p) security required pursuant to section 190 of the Act;
- (q) minerals sought;
- (r) consents.

(2) The register may be searched during the hours prescribed for the conduct of business at the office of the mining registrar for the mining district of Brisbane on payment of the prescribed fee.

(3) The register may be maintained manually, on computer disc or in such other form as may be adopted by the chief executive.

Request for registration of execution

31.(1) A request for registration of an execution of the interest of a holder of a mineral development licence is to be made to the chief executive in the approved form and is to be accompanied by—

- (a) an office copy or a certified copy of the execution evidencing the authority to seize and sell the interest; and
- (b) the prescribed fee.

(2) The assignment of the interest pursuant to registration of an execution is to be in the approved form and is to be accompanied by the prescribed assignment fee.

Instrument of mortgage

32. The chief executive is not to record particulars of a mortgage over a mineral development licence unless 2 copies of the executed instrument of mortgage are lodged with the chief executive in the approved form and accompanied by the prescribed fee.

Sale by mortgagee

33.(1) When a mortgagee exercises a power of sale contained or implied in a mortgage over a mineral development licence the mortgagee is to—

- (a) furnish the Minister with satisfactory evidence that the power of sale has been properly exercised; and
- (b) submit the assignment of the interest pursuant to the exercise of the power of sale in accordance with the provisions of section 198 of the Act; and
- (c) pay the prescribed assignment fee.

(2) An assignment by a mortgagee exercising power of sale under a mortgage over a mineral development licence, is to be made in the approved form and is to be accompanied by—

- (a) a copy of the government gazette and of a newspaper circulated in the locality, containing the notice of the mortgagee's intention to sell; and
- (b) the instrument of mineral development licence; and
- (c) the duplicate of the mortgage under which the sale was made.

Rental payable on mineral development licence

34.(1) In this section—

"yearly rental rate" for a mineral development licence means the yearly rental rate mentioned in schedule 3 for the particular year the licence is in force from the day of its grant.

(2) The yearly rental rate payable under a mineral development licence for each hectare of land covered by the licence for the particular year of the licence is—

- (a) for the first 1 000 ha—100% of the yearly rental rate; and
- (b) for the next 1 000 ha—40% of the yearly rental rate; and
- (c) for the next 3 000 ha—25% of the yearly rental rate; and
- (d) for the next 10 000 ha—5% of the yearly rental rate; and
- (e) for each additional hectare—1% of the yearly rental rate.

PART 7—MINING LEASES

Conditions of mining lease

35. For the purposes of section 276 of the Act the prescribed conditions of a mining lease are that the holder of the mining lease and all persons acting under the authority of the lease—

- (a) are to take every precaution to ensure there is no dispersal of parthenium weed seed or the seed of any other declared plant within the meaning of the *Rural Lands Protection Act 1985* as a result of mining activities or as a result of access to the area of the mining lease; and
- (b) are to restrain animals in the custody of that person unless the area of the lease is fenced in such a manner as to contain those animals; and
- (c) are not to discharge a firearm on occupied land unless the holder has obtained the written consent of the owner and that consent has been lodged with the mining registrar.

Register of mining leases

36.(1) A mining registrar must record the following particulars of each application for a mining lease and each mining lease in the register—

- (a) name of each holder and interest held;
- (b) name and address of 1 person for service of notices on the holder;
- (c) name of mining lease;
- (d) number of mining lease;
- (e) mining district in which the land the subject of the mining lease is situated;
- (f) locality;
- (g) date and time of marking out;
- (h) date and time of application;
- (i) date certificate of application issued;

- (j) date of grant of mining lease or abandonment or rejection of application;
- (k) term;
- (l) renewals;
- (m) date of expiry, cancellation or surrender;
- (n) surface area;
- (o) area;
- (p) local government;
- (q) caveats;
- (r) warrants of execution;
- (s) annual rental;
- (t) security required pursuant to section 277 of the Act;
- (u) minerals or other purposes for which mining lease is sought;
- (v) subleases.

(2) The register may be searched during the hours prescribed for the conduct of business of the office of the mining registrar on payment of the prescribed fee.

(3) The register may be maintained manually, on computer disc or in such other form as may be adopted by direction from the chief executive.

Copies of mining lease applications

37.(1) The mining registrar may give to a person a copy of a mining lease application.

(2) However, the mining registrar must not give the person a copy of any statement detailing the financial and technical resources that accompanied the application.

Request for registration of execution

38.(1) A request for registration of an execution of an interest of a holder of a mining lease is to be made to the mining registrar in the approved form

and is to be accompanied by-

- (a) an office copy or a certified copy of the execution evidencing the authority to seize and sell the interest; and
- (b) the prescribed fee.

(2) The assignment of the interest executed by the person appointed to make the seizure is to be in the approved form and is to be accompanied by the prescribed assignment fee.

Excavations near railway land

39.(1) The holder of or applicant for a mining lease is not to make any excavation within a distance of 12 m in a horizontal direction or of 15 m in a vertical direction from any embankment, cutting, bridge, pier, culvert, drain or other work on a railway line passing over or near to the land comprised in the mining lease or application without the authority in writing of the chief executive of Queensland Rail.

Maximum penalty-200 penalty units.

(2) The request for the authority of the chief executive of Queensland Rail is to be made in the first instance to the chief executive.

Moving datum post after survey of contiguous land

40.(1) Where the land the subject of an application for a mining lease is shown in the application as being contiguous with other land which is the subject of—

- (a) a mining claim; or
- (b) a mining lease; or
- (c) an application for a mining claim; or
- (d) an application for a mining lease;

and that other land is not surveyed, then, within 14 days (or such longer period as the Minister in the particular case allows) after the mining registrar has notified the applicant for the mining lease in writing that a survey of that other land has been completed and that all survey marks defining the boundary of the other land have been placed, the applicant for the first mentioned mining lease may adjust the marking out of the land so that the land applied for is still contiguous with that other land as surveyed and may be surveyed accordingly.

(2) Subsection (1) does not authorise the adjustment of the marking out of any land so as to include land which was not land to which the applicant's prospecting permit, exploration permit or mineral development licence applied at the date the application for the mining lease was made, or the surveying of that land.

(3) When the marking out of the land comprised in the application has been adjusted or the land has been surveyed, the land is to be the land marked out and applied for by the applicant pursuant to the provisions of the Act.

Instrument of mortgage

41. A mining registrar is not to record particulars of a mortgage over a mining lease unless 2 copies of the executed instrument of mortgage are lodged with the mining registrar in the approved form and accompanied by the prescribed fee.

Sale by mortgagee

42.(1) When a mortgagee exercises a power of sale contained or implied in a mortgage over a mining lease the mortgagee is to—

- (a) furnish the mining registrar with satisfactory evidence that the power of sale has been properly exercised; and
- (b) submit the assignment of the interest pursuant to the exercise of the power of sale in accordance with the provisions of section 300 of the Act; and
- (c) pay the prescribed assignment fee.

(2) An assignment by a mortgagee exercising power of sale under a mortgage over a mining lease, is to be made in the approved form, and is to be accompanied by—

(a) a copy of the government gazette and of a newspaper circulated in the locality, containing the notice of the mortgagee's intention to sell; and

- (b) the instrument of mining lease the subject of the sale; and
- (c) the duplicate of the mortgage under which the sale was made.

Submission of returns of additional activities

43.(1) A person who carries out additional activities on land the subject of a mining lease application with the approval in writing of the Minister pursuant to section 315 of the Act is to furnish a return to the chief executive setting out the details and results of all such activities.

(2) A return required by this regulation is to be lodged within 3 months of the expiry of the approval.

Rental payable on mining lease

44.(1) Subject to subsection (2), the yearly rental on a mining lease is set out in schedule 3.

(2) If—

- (a) the holder of a mining lease that was due for renewal before the commencement of the Act applied before the commencement for a renewal of the lease; and
- (b) the lease is renewed after the commencement;

the yearly rental payable for the term of the renewed lease is the rental payable at the time the term is taken to have commenced under section 286(7) of the Act.

PART 8—EFFECT ON TOWN PLANNING PROVISIONS¹

PART 9—ROYALTIES

Rate of royalty

45.(1) The rate of royalty payable under the Act or any other Act relating to mining is prescribed in schedule 1.

(2) Each provision of the schedule applies to mineral sold, disposed of or used in a royalty period.

Definition for pt 9

46. In this part—

"year" means the period of time from and including 1 July in any year to and including 30 June in the next succeeding year.

Royalty return

47. A royalty return is to be lodged in the approved form with the chief executive and is to be accompanied by—

- (a) the documentary evidence necessary to substantiate the information supplied in the return; and
- (b) the amount of royalty payable.

Chief executive to assess royalty payable

48. The chief executive is to assess the actual amount of royalty payable and—

(a) if the amount assessed is less than the amount paid—is to refund the excess amount; or

¹ For ease of reference, the part heading has been included to mirror the structure of the *Mineral Resources Act 1989*.

(b) if the amount assessed is greater than the amount paid—is to request by notice in writing to the person liable to pay the royalty that the outstanding amount be paid within 30 days from the notice or such further period as the chief executive, in special circumstances, may approve.

Minister may allow different meaning of year

49. If the Minister approves in writing, the holder of a mining claim or mining lease or other authority under this Act or any other Act relating to mining may adopt a period of 12 months ending on some date other than 30 June for the purpose of lodgment of a royalty return.

Period within which royalty return is to be lodged

50.(1) Unless the Minister determines otherwise, a royalty return is to be lodged in the approved form—

- (a) on or before 30 September of each year; or
- (b) within 3 months from the date of expiry of the year as allowed by the Minister pursuant to section 50; or
- (c) within 3 months of cessation of the mining of minerals within the State; or
- (d) within such further period as the Minister may allow after application by the person obliged to lodge the royalty return.

(2) The Minister may direct the holder of a mining claim or mining lease or other authority under this Act or any other Act relating to mining to lodge a royalty return at such intervals, being intervals of less than 12 months as may be specified in the direction.

Minister may determine value

51.(1) For the purpose of calculating the amount of royalty payable pursuant to part 9 of the Act the Minister may determine from time to time the value of any mineral or minerals sold, disposed of or used.

(2) The Minister may make a determination whether or not consideration was received for the mineral or minerals.

Valuation and royalty payable on cessation of mining operation

56. Upon the cessation of a mining operation the Minister may apply an appropriate value to stocks of mineral on hand and in the possession of a holder and direct that royalty be paid thereon.

Rate of interest on unpaid royalty

57. For the purposes of section 332 of the Act, the prescribed rate of interest on unpaid royalty shall be the average of the prime rates of interest of the following Trading Banks—

- (a) Australian & New Zealand Banking Group Ltd;
- (b) Commonwealth Banking Corporation;
- (c) National Australia Bank Ltd;
- (d) Westpac Banking Corporation Ltd;

as published in the financial press on the Monday immediately prior to the date on which interest commences to apply.

PART 10—ADMINISTRATION AND JUDICIAL FUNCTIONS

Seal of Wardens Court

58. The seal of a Wardens Court shall bear a Crown surrounded by the words 'Wardens Court' naming the mining district where the Wardens Court is held, and all notices, summonses, certificates, warrants and other process or documents issued out of a Wardens Court shall be sealed with the seal of the Wardens Court.

PART 11—GENERAL

Issue of duplicate permits, leases etc.

59.(1) An application for the issue of—

- (a) a duplicate prospecting permit, certificate of grant of mining claim or instrument of mining lease is to be made in writing to the mining registrar;
- (b) a duplicate instrument of exploration permit or mineral development licence is to be made in writing to the chief executive.

(2) Each application is to be accompanied by a statutory declaration under the provisions of the *Oaths Act 1867* declaring—

- (a) the circumstances surrounding the loss or destruction of the document the subject of the application; and
- (b) in the case of loss—action taken to locate the document; and
- (c) the prescribed fee. Hours of business

60. The hours of business of the offices of a mining registrar are to be 8.30 a.m. to 4.30 p.m. Monday to Friday other than gazetted public holidays and other days approved by the chief executive.

Offence of false or misleading statement

61. A person is not to make a statement in any application made pursuant to the provisions of the Act knowing that it is false or misleading in a material particular.

Maximum penalty—200 penalty units.

Priority of registration

62. Where—

- (a) a document duly executed is lodged for registration; and
- (b) the document cannot be registered because the original instrument

evidencing an interest or application for an interest under the authority of the Act is not produced at that time; and

(c) another duly executed document is lodged together with that original instrument of interest or application for an interest under the authority of the Act;

the chief executive or mining registrar as the case may be is to register first the document referred to in paragraph (c).

Restrictions on grants

63.(1) In this section and in schedule 4, part 2—

"restriction" means a restriction of a kind specified in schedule 4, part 1.

(2) Land within a restricted area is subject to the restrictions that are specified in schedule 4, part 2 for the restricted area.

(3) If a restriction prohibits the grant, or application for the grant, of—

- (a) a prospecting permit; or
- (b) a mining claim; or
- (c) an exploration permit; or
- (d) a mineral development licence; or
- (e) a mining lease;

in relation to land within a restricted area, the restriction does not affect the grant of a permit, claim, licence or lease on an application made, but not finally dealt with, before the day on which the area was included in schedule 4, part 2 or the restriction was applied to the area.

Prohibition against interference with roads and water

64.(1) A person is not to sink a shaft, or disturb the surface of the ground, or erect any works, or deposit earth or other material so as to interfere with the supply of water used by the public, or so as to obstruct a formed road surface unless it is expressly authorised in a grant or authorisation under the Act.

Maximum penalty—200 penalty units.

(2) A person is not to undermine a formed road surface in such a manner as to endanger any person who uses that road surface.

Maximum penalty-200 penalty units.
```

Wilful damage to markings

65. A person is not to wilfully damage, destroy, remove or otherwise interfere with any post, cairn of stones, marking, posted notice, certificate or survey mark placed or used under the Act and still required.

Maximum penalty-200 penalty units.

Holder of mining claim or mining lease to furnish information

66. The holder of a mining claim or mining lease is to furnish information whenever required by the chief executive in such manner and form as the chief executive determines.

Maximum penalty—200 penalty units.
```

Giving and publishing information about minerals

67.(1) The purpose of this section is to enhance knowledge of the mineral resources of the State.

(2) When requested by the chief executive, a person must give the chief executive information about minerals mined, processed, sold, disposed of or used.

Maximum penalty-200 penalty units.

(3) The information must be given in the way and form the chief executive decides.

(4) The chief executive may publish statistics derived from the information in the way the chief executive decides.

Entry of transmission by death without probate or administration

68.(1) In the case of the death of the holder of a mining claim, exploration permit, mineral development licence or mining lease the

Minister may, if satisfied-

- (a) that a will has been left by that holder, and that probate of such will or administration with such will annexed has not been granted within 6 months after death, or that a will has not been left, and that administration of the estate has not been granted within that time; and
- (b) that the value of the estate is not sufficient to justify the expense of taking out probate or administration;

cause transmission by death to be entered in the appropriate register relating to the mining claim, exploration permit, mineral development licence or mining lease as if probate or letters of administration with the will annexed or, if the deceased died without leaving a will, letters of administration had been duly granted.

(2) After transmission by death has been entered, the person or persons to whom the estate or interest of the deceased holder of the mining claim, exploration permit, mineral development licence or mining lease has been transmitted are to have all rights, powers and liabilities concerning the interest as if probate, or administration with the will annexed, or administration of the estate of the deceased person had been granted to that person or those persons.

Request for entry of transmission by death without probate or administration

69. A request pursuant to the provisions of section 69 is to be made in writing in the approved form and be accompanied by—

- (a) a certified copy of entry of record of death; and
- (b) if a will has been left—that will; and
- (c) the certificate of grant of claim, permit, licence or instrument of lease the subject of the request; and
- (d) the prescribed fee.

Request for transmission by death

70. A request for transmission by death of the interest of a deceased

holder of a mining claim, exploration permit, mineral development licence or mining lease by virtue of grant of probate or letters of administration is to be made in the approved form and be accompanied by—

- (a) a certified copy of the grant of probate or administration or other document evidencing the claim of the application to such transmission; and
- (b) the certificate of grant of mining claim, instrument of exploration permit, mineral development licence or mining lease the subject of the request; and
- (c) the prescribed fee.

Request for transmission in bankruptcy

71.(1) A request for transmission in bankruptcy of the interest of a holder of a mining claim, exploration permit, mineral development licence or mining lease is to be made in the approved form and be accompanied by a certified copy of the sequestration order, certificate of appointment or other document evidencing the claim of the applicant and the prescribed fee.

(2) If the request is pursuant to any composition, scheme of arrangement or assignment or to any deed of arrangement the document evidencing such composition, scheme or arrangement is to be produced for inspection.

Request to record death of joint holder

72. A request to record death of a holder in respect of any joint interest in a mining claim, exploration permit, mineral development licence or mining lease is to be made in the approved form and is to be accompanied by—

- (a) a certified copy of entry of record of death; and
- (b) the certificate of grant of mining claim, exploration permit, mineral development licence or mining lease the subject of the request; and
- (c) the prescribed fee.

Request for change or correction of name

73.(1) A holder of a prospecting permit, mining claim, or mining lease may apply to the mining registrar to record a change or correction of name of that holder and a holder of an exploration permit or mineral development licence is to apply to the chief executive.

(2) A request is to be made in the approved form and be accompanied by proof of change of name which is to include—

- (a) a certified copy of entry of record evidencing change of name or correct name; and
- (b) the prospecting permit, certificate of grant of mining claim, instrument of mineral development licence or mining lease the subject of the request; and
- (c) the prescribed fee.

Lodgment of survey plans

74.(1) Where a survey plan is lodged for registration pursuant to section 7.45^2 of the Act the plan, if lodged by a person other than an officer of the department, is to be accompanied by the prescribed fee.

(2) Where—

- (a) a survey plan is lodged with the chief executive pursuant to section 7.45 of the Act or pursuant to a request in accordance with the provisions of section 407 of the Act; and
- (b) the chief executive is of the opinion that the survey plan is not in accordance with the Act or with instructions issued pursuant to the Act;

the chief executive may-

- (c) issue requisitions pertaining to the survey;
- (d) require satisfaction of requisitions within a specified time;
- (e) reject the plan of survey at any time prior to its registration.

² Section 7.45 has been omitted from the *Mineral Resources Act 1989*.

Time of lodgment to be noted

75. The mining registrar or the chief executive as the case may be is to cause to be endorsed on every application for a mining claim, exploration permit or mineral development licence or mining lease lodged as prescribed, the day and hour of the lodgment of the application.

SCHEDULE 1

RATE OF ROYALTIES

section 45

PART 1—ROYALTIES FOR COPPER, GOLD, LEAD, SILVER AND ZINC

Division 1—Application and choices about royalties

Application of part

1. This part only applies to the following minerals—

- (a) copper;
- (b) gold;
- (c) lead;
- (d) silver;
- (e) zinc.

Royalty rates and choices

2.(1) The royalty rate for copper, gold, lead, silver and zinc is 2.7%.

(2) However, a person paying royalty may, when first giving the chief executive a royalty return for mineral sold, disposed of or used after 31 December 1995 (other than as a bulk sample approved by the Minister), decide to pay royalty for a mineral at the rate worked out under division 2.

(3) If the person decides to pay the royalty for a mineral under division 2, the person must pay royalty for the mineral under division 2 for all mineral sold, disposed of or used before 1 January 2001.

Division 2—Variable royalty rates

Royalty rates and royalty base rates

3.(1) This division sets royalty rates for copper, gold, lead, silver and zinc using reference prices and royalty base rates.

(2) Reference prices and royalty base rates are used to work out royalty rates for minerals.

Reference prices

4.(1) This section sets prices (**"referenceprices"**) for copper, gold, lead, silver and zinc.³

- (2) Reference prices are in Australian dollars.
- (3) Reference prices for copper, lead and zinc are for a tonne of mineral.
- (4) Reference prices for silver and gold are for a troy ounce of mineral.
- (5) The first reference price ("reference price 1") is as follows—
 - (a) for copper—\$2 640;
 - (b) for gold—\$430;
 - (c) for lead—\$740;
 - (d) for silver—\$5.00;
 - (e) for zinc—\$1 455.

(6) The second reference price ("reference price 2") is as follows—

- (a) for copper—\$3 300;
- (b) for gold—\$540;
- (c) for lead—\$925;
- (d) for silver—\$7.00;
- (e) for zinc—\$1 815.

³ The reference prices for these minerals will be reviewed before 1 January 2001.

(7) The third reference price ("reference price 3") is as follows—

- (a) for copper—\$4 180;
- (b) for gold—\$680;
- (c) for lead—\$1 170;
- (d) for silver—\$9.00;
- (e) for zinc—\$2 300.

Royalty base rates

5.(1) This section sets royalty rates (**"royalty base rate"**) for copper, gold, lead, silver and zinc (the **"mineral"**) at reference prices.

(2) The royalty base rate for the mineral is—

- (a) at reference price 1-1.5% of the value of the mineral; or
- (b) at reference price 2-2.5% of the value of the mineral; or
- (c) at reference price 3-4.5% of the value of the mineral.

Working out royalty rates

6.(1) To work out the actual royalty rate for a mineral, work out the average market price and compare it with the mineral's reference price.

(2) If the average market price is lower than reference price 1, the royalty rate is the royalty base rate for reference price 1.

(3) If the average market price is higher than reference price 3, the royalty rate is the royalty base rate for reference price 3.

(4) If the average market price is equal to or higher than reference price 1 but lower than reference price 2, the royalty rate payable is the total of the royalty base rate at reference price 1 and 1% of the relevant percentage, rounded down to 2 decimal places.

(5) If the average market price is equal to or higher than reference price 2 but not higher than reference price 3, the royalty rate payable is the total of the royalty base rate at reference price 2 and 2% of the relevant percentage,

rounded down to 2 decimal places.

(6) In this section—

"relevant percentage" means-

- (a) for subsection (4)—the difference between reference price 1 and the average market price expressed as a percentage of the difference between reference prices 1 and 2; or
- (b) for subsection (5)—the difference between reference price 2 and the average market price expressed as a percentage of the difference between reference prices 2 and 3.

Examples-

1. For subsection (2), if the average market price is 2200, the royalty payable for copper is 1.5%.

2. For subsection (3), if the average market price is 4200, the royalty payable for copper is 4.5%.

3. For subsection (4), if the average market price is 3000, the royalty payable for copper is 2.04% (1.5% plus .54%).

4. For subsection (5), if the average market price is 3700, the royalty payable for copper is 3.4% (2.5% plus 0.45% x 2).

Division 3—Other provisions about royalties

Basis for working out values

7. For working out royalties payable for copper, gold, lead, silver and zinc, the value of the mineral is the value of payable metal before deducting land transport, smelting and refining charges, but after deducting sea transport costs to ports outside Queensland or any other costs that, in the Minister's opinion, are reasonable.

General concessions

8.(1) For each mining project, no royalty is payable on the first \$30 000 of the value of mineral sold, disposed or used from the project for a royalty period.

(2) For each mining project's production of copper, lead and zinc, only half royalty is payable on the next \$4 million of the total value of the copper, lead and zinc for a royalty period.

(3) If a mining project is not operational for a part of a royalty period, the amount mentioned in subsection (2) must be reduced by the percentage of the royalty period when the mining project was not operational.

Royalty discounts

9.(1) This section applies to royalties payable for copper, lead and zinc sold, disposed of or used after 31 December 1997 and smelted or refined in Queensland ("processed mineral").

(2) If there is at least 95% metal in processed mineral, the royalty payable for the processed mineral must be reduced by the following percentage—

- (a) for copper—20%;
- (b) for lead—25%;
- (c) for zinc—35%.

PART 2—ROYALTIES FOR OTHER MINERALS

Royalties on certain minerals

10. The royalty payable on each tonne of a mineral specified in the following table is shown opposite the mineral—

Silica and mineral sands

11. The royalty payable on silica (as distinct from sand and silicates) is the higher of the following—

- (a) 5% of the silica's value;
- (b) 50 cents per tonne of silica.

Mineral sands

12. The royalty payable on rutile, monazite, zircon and ilmenite concentrates is 5% of the value of the concentrate.

Coal

13.(1) In this section—

"domestic coal" means coal mined other than export coal mined.

- "export coal" means coal exported to another State, a Territory or a foreign country.
- "open-cut coal mine" has the meaning given by the Coal Mining Act 1925.
- "underground coal mine" has the meaning given by the *Coal Mining Act* 1925.
- "value" of coal means the value worked out by the Minister under section 51.
 - (2) The royalty payable on export coal is 7% of the coal's value.

(3) However, the royalty payable on export coal is that payable under subsection (4) if the coal is hauled—

- (a) under a written rail haulage arrangement for coal executed before 1 January 1991; or
- (b) under a written rail haulage arrangement for coal executed after 31 December 1990 that makes provision for a resource utilisation charge or coal price adjustment; or
- (c) under the terms of a written offer of a rail haulage arrangement made after 30 April 1992 that makes provision for a resource utilisation charge.
- (4) The royalty payable is—
 - (a) if the coal is mined from an open-cut coal mine—5% of the coal's value; or
 - (b) if the coal is mined from an underground coal mine—4% of the coal's value.
- (5) The royalty payable on domestic coal is—
 - (a) for the calendar year—
 - (i) 1994—1% of the coal's value; and
 - (ii) 1995—2% of the coal's value; and
 - (iii) 1996—3% of the coal's value; and
 - (iv) 1997—4% of the coal's value; and
 - (v) 1998—5% of the coal's value; and
 - (vi) 1999-6% of the coal's value; and
 - (b) after 1999—7% of the coal's value.

Coal—certain mines

13A.(1) This section applies to the following mines—

- (a) the Goonyella mine on mining leases 1763 and 70038;
- (b) the Norwich Park mine on mining leases 1782 and 70127;

- (c) the Peak Downs mine on mining leases 1775, 1783 and 1885;
- (d) the Saraji mine on mining leases 1775, 1782, 1784, 2360 and 2410;
- (e) the Riverside mine on mining leases 1764, 1802, 1900 and 70121.

(2) The royalty payable on each tonne of export coal hauled, in relation to coal mined from a mine, is—

- (a) for the mine's base tonnage—
 - (i) 5% of the coal's value; and
 - (ii) the amount (rounded to a second decimal place), for each tonne of coal, calculated using the following formula—

base special royalty x $\frac{CPI_{NOW}}{CPI_{BASE}}$; and

(b) for each tonne of coal over the mine's base tonnage—7% of the coal's value.

(3) However, the royalty payable on export coal mined from the Goonyella mine by the lessee of the Riverside mine, and hauled from the Riverside mine, is 7% of the coal's value.

(4) The number of tonnes of export coal hauled is to be determined by reference to the hauler's final invoice.

(5) If the Minister directs royalty returns be lodged at intervals of less than 1 year,⁴ the Minister (for the purpose of calculating the royalty payable for the interval) may—

- (a) determine how many of the tonnes of coal hauled in the interval are to be treated as part of the base tonnage; or
- (b) use a CPI_{NOW} figure that the Minister estimates will be the CPI_{NOW} figure for the year or other period to which the calculation would, but for the direction, relate.

(6) If the Minister exercises a power under subsection (5)(a) or (b), the

⁴ This direction is given under section 50(2) of the regulation.

Minister must-

- (a) recalculate the royalty using the actual CPI_{NOW} figure and the actual coal hauled figures, once they are known; and
- (b) reconcile any over-payment or under-payment of royalty revealed by the recalculation.
- (7) In this section—

"base special royalty" means-

- (a) for the Goonyella mine—\$5.38; or
- (b) for the Norwich Park mine—\$8.14; or
- (c) for the Peak Downs mine—\$6.78; or
- (d) for the Saraji mine—\$9.13; or
- (e) for the Riverside mine—\$9.08.

"base tonnage" means-

- (a) for the Goonyella mine—
 - (i) in the year 2000—the first 2 203 732 tonnes of coal (other than coal hauled from the Riverside mine) hauled in a year; or
 - (ii) in any other year—the first 6 611 196 tonnes of coal (other than coal hauled from the Riverside mine) hauled in a year; or
- (b) for the Norwich Park mine—
 - (i) in the year 2000—the first 1 723 660 tonnes of coal hauled in a year; or
 - (ii) in any other year—the first 5 170 980 tonnes of coal hauled in a year; or
- (c) for the Peak Downs mine—
 - (i) in the year 2000—the first 2 050 979 tonnes of coal hauled in a year; or
 - (ii) in any other year-the first 6 152 937 tonnes of coal hauled

in a year; or

- (d) for the Saraji mine—
 - (i) in the year 2000—the first 1 672 722 tonnes of coal hauled in a year; or
 - (ii) in any other year—the first 5 018 167 tonnes of coal hauled in a year; or
- (e) for the Riverside mine—
 - (i) in the year 1998—the first 1 378 082 tonnes of coal (other than coal mined from the Goonyella mine) hauled in a year; or
 - (ii) in any other year—the first 4 134 246 tonnes of coal (other than coal mined from the Goonyella mine) hauled in a year.
- "CPI_{BASE}" means the 'Consumer Price Index: All Groups Index Numbers—Weighted average of eight capital cities' published by the Australian Bureau of Statistics, for the March quarter 1997.
- "CPI_{NOW}" means the 'Consumer Price Index: All Groups Index Numbers—Weighted average of eight capital cities' published by the Australian Bureau of Statistics, for the calendar quarter immediately before the calendar quarter to which the calculation relates.

"export coal" see section 13.

"year" means a year commencing on 1 June.

(8) The following provisions of this section expire on 30 September 1998—

- (a) subsections (1)(e), (3) and (6);
- (b) paragraph (e) of the definitions **"base special royalty"** and **"base tonnage"** in subsection (5).
- (9) This section expires on 30 September 2000.

Bauxite

14.(1) The royalty payable on bauxite mined for consumption outside the State is the higher of the following—

- (a) 10% of the net f.o.b. return per tonne taking into account income of any type arising directly from the sale, disposal or use of the bauxite, but not a deduction for royalty;
- (b) \$1 per tonne.

(2) The royalty payable on bauxite mined for consumption within the State is half the royalty worked out under subsection (1).

Corundum, gemstones and precious stones

15.(1) This section applies only if the value of corundum, gemstones or precious stones sold, disposed of or used in a royalty period is more than \$30 000.

(2) The royalty payable on corundum, gemstones and precious stones, including agate, sapphire and opal, is 2.7% of the value of the corundum, gemstones or precious stones after deducting \$30 000 from the value.

Phosphate

16.(1) The royalty payable on phosphate won by Queensland Phosphate Limited from the Phosphate Hill project for use in phosphoric acid or high analysis fertilisers is the higher of the following—

- (a) 74 cents per dry tonne of phosphate;
- (b) the royalty worked out under subsection (2) (the "escalated royalty").

(2) The escalated royalty is the base rate in May 1987 terms of 74 cents per dry tonne of phosphate rock from the treatment plant at Phosphate Hill, escalated quarterly by the percentage movement between—

- (a) the base triple superphosphate price at May 1987 of \$200 per tonne; and
- (b) the average, for each month in the quarter, of the higher of the

following-

- (i) the US Gulf export f.o.b. market price in US dollars for triple superphosphate, as published in Green Markets magazine, converted to Australian dollars at the exchange rate prevailing on the last day of the month;
- (ii) the price fixed by the Australian Customs Service as the normal (undumped) US Gulf export f.o.b. price for triple superphosphate, converted to Australian dollars at the exchange rate prevailing on the last day of the month.

(3) If subsection (1) does not apply, the royalty payable on phosphate is 10% of the value of the phosphate.

Gaseous hydrocarbons

17.(1) The royalty on gaseous hydrocarbons is payable at the rate applying to petroleum under the *Petroleum Act 1923*, section 55(1).

(2) However, royalty is not payable on gaseous hydrocarbons that the person paying the royalty flares, vents or uses for prospecting for, or recovering, gaseous hydrocarbons.

(3) For subsection (1), the way for working out the value of gaseous hydrocarbons is the way stated in the *Petroleum Act 1923*, section 57.

Other minerals

18.(1) This section applies to a mineral not already mentioned in this schedule.

(2) The royalty rate payable on the mineral is 2% of the gross proceeds of the sale, disposal or use of the mineral for each year, after deducting \$30 000 from the gross proceeds.

Oil shale

18A.(1) The royalty payable on oil processed from oil shale is the lesser of—

- (a) 10% of the oil's value; or
- (b) the WTI%, rounded to a second decimal place, of the oil's value.
- (2) The WTI% is worked out using the formula—

WTI% = $\left(\frac{[CPI_{BASE}]}{CPI_{NOW}} \times WTI\right]^2 \div 1\ 000\) + 0.5$

- (3) In subsection (2)—
- "CPI" means the 'Consumer Price Index: All Groups Index Numbers—Weighted average of eight capital cities' published by the Australian Bureau of Statistics.
- "CPI_{BASE}" means the CPI for the December quarter 1993.
- "CPI_{NOW}" means the CPI for the calendar quarter to which the calculation relates.
- **"WTI"** means the 'Crude Oil West Texas—Spot—Last' price in US dollars per barrel published in the Australian Financial Review, converted to Australian dollars at the hedge settlement rate, for each day of trading, averaged over the calendar quarter to which the calculation relates.

Example of how to work out royalty payable-

The CPI_{BASE} is 110.0. If, for a particular quarter, the CPI is 134.2 and the WTI is \$A30, then the WTI% = $([110.0 \times 30]^2 \div 1000) + 0.5$

Because 1.10% is less than 10%, the royalty payable is 1.10% of the oil's value.

(4) No royalty is payable on the first 1 600 000 barrels of oil processed, in a calendar year, from oil shale from mining lease 80003.

(5) If less than 1 600 000 barrels are processed in any calendar year, the shortfall can be carried forward (and added to the 1 600 000 exemption) for

the next calendar year.

(6) However, any unused shortfall can not be carried forward beyond that next calendar year.

Example—

In 1998, 1 300 000 barrels are produced.

In 1999, 1 700 000 barrels are produced.

In 2000, 2 000 000 barrels are produced.

In 1998, no royalty is payable because production is 300 000 below 1 600 000. The shortfall of 300 000 is carried forward to 1999.

In 1999, no royalty is payable because production is 200 000 below 1 900 000 (ie. 1 600 000 + 300 000). There is no shortfall from 1999 to carry forward because 1 700 000 is above 1 600 000. Also, the unused shortfall from 1998, ie 200 000, is not carried forward to 2000.

In 2000, royalty is payable on the 400 000 barrels produced above 1 600 000, with no shortfall to be carried forward.

(7) In this section—

- **"shortfall"** means the shortfall between the number of barrels actually processed and 1 600 000 barrels.
- "**unused shortfall**" means any shortfall that was carried forward but not used in the year in which it was carried forward.

(8) Subsections (4) to (8) expire on 1 January 2006.

PART 3—TRANSITIONAL PROVISIONS

Transitional provisions for pt 1

19.(1) The amount of royalty payable for mineral sold, disposed of or used before 1 January 1996 must be worked out under the relevant provision.

(2) For 1996, the amount of royalty payable is either—

- (a) if the amount worked out under the relevant provision is lower than the amount worked out under part 1—the lower amount plus one-third of the difference between the amounts; or
- (b) if the amount worked out under the relevant provision is higher than the amount worked out under part 1—the higher amount less one-third of the difference between the amounts.
- (3) For 1997, the amount of royalty payable is either—
 - (a) if the amount worked out under the relevant provision is lower than the amount worked out under part 1—the lower amount plus two-thirds of the difference between the amounts; or
 - (b) if the amount worked out under the relevant provision is higher than the amount worked out under part 1—the higher amount less two-thirds of the difference between the amounts.
- (4) In this section—

"relevant provision" means—

- (a) for copper, lead, silver and zinc derived from mining on mining lease 8058—section 21; or
- (b) for copper, gold, lead, silver and zinc derived from mining somewhere else—section 19.

Transitional provisions for mining lease 8058

20.(1) This section applies to—

- (a) copper, lead, silver and zinc derived from mining on mining lease 8058; and
- (b) royalty payable after 27 June 1993.

(2) The royalty payable on copper is 4.5% of the copper sales revenue.

(3) The royalty payable on lead, silver and zinc is 2.7% of the lead, silver and zinc sales revenue.

(4) The sales revenue from copper, lead, silver or zinc is the gross sales revenue receivable for the sale of payable copper, lead, silver or zinc—

- (a) before deducting smelting, refining or transport costs; and
- (b) after deducting any allowance that, in the Minister's opinion, is reasonable.
- (5) The sales revenue—
 - (a) includes—
 - (i) for a sale made and finalised in the royalty period—the proceeds of the sale; and
 - (ii) for a sale not finalised in the royalty period—the proceeds of the sale worked out on a best estimate basis; and
 - (iii) exchange gains and losses because of currency fluctuations between the day of sale and the day of payment; and
 - (b) does not include sales revenue from the following-
 - (i) copper derived when processing lead, silver or zinc;
 - (ii) lead, silver or zinc derived when processing copper;
 - (iii) metals other than copper, lead, silver or zinc;
 - (iv) the processing of stocks of apparently untreatable material held on 27 June 1993.

(6) However, if the sales revenue for a particular royalty period includes an amount worked out on a best estimate basis, the sales revenue for the royalty period must be adjusted in the royalty return for the royalty period in which the actual proceeds of the sale become known, to take into account the difference between the estimate and the actual proceeds of the sale.

21. This part expires on 1 July 1998.
