# **GOVERNMENT OWNED CORPORATIONS (QUEENSLAND INVESTMENT CORPORATION) REGULATION 1994**

[as amended by all amendments that commenced on or before 15 November 2002]

## **PART 1—PRELIMINARY**

### **1 Short title**

This regulation may be cited as the *Government Owned Corporations (Queensland Investment Corporation) Regulation 1994*.

### **2 Commencement**

The following provisions commence on 1 October 1994—

- part 3 (Candidate GOC declared to be a GOC)
- part 4 (Amendment of Government Owned Corporations Regulation 1993).

### **3 Purpose**

The purpose of this regulation is—

- (a) to take the preparatory steps necessary for declaring a candidate GOC, Queensland Investment Corporation, to be a GOC; and
- (b) to declare the candidate GOC to be a GOC; and
- (c) to provide for matters about QIC after QIC is declared to be a GOC.

#### **4 Meaning of “QIC”**

In this regulation—

“QIC” means Queensland Investment Corporation.

## **PART 2—SHARE CAPITAL**

### **5 QIC’s share capital**

(1) On the commencement of this section, QIC is taken to have a share capital of \$10 000 000, made up of 10 000 000 ordinary shares of \$1 each.<sup>1</sup>

(2) On the commencement of this subsection, QIC has a share capital of \$100 000 000, made up of 100 000 000 ordinary shares of \$1 each.

(3) Under section 58 of the Act, 1 003 604 of the shares have been issued.<sup>2</sup>

(4) QIC must issue a further 8 996 396 of the shares as soon as it is practicable to issue the shares.

(5) Shares issued under subsection (4) are taken to have been issued on the commencement of subsection (4).

(6) QIC must issue a further 6 000 000 of the shares as soon as it is practicable to issue the shares.

(7) Shares issued under subsection (6) are taken to have been issued on the commencement of subsection (6).

(8) QIC must issue a further 4 000 000 of the shares as soon as it is practicable to issue the shares.

(9) Shares issued under subsection (8) are taken to have been issued on the commencement of subsection (8).

1 This section provides for QIC’s authorised share capital. Under section 58(2) of the Act, before QIC becomes a GOC, it must apply the part of its capital that the responsible Ministers direct in paying up, in full, shares in itself.

2 Under the Act, each of QIC’s 2 shareholding Ministers holds an equal number of the issued shares (see sections 71 to 74 of the Act).

### **8 Declaration of candidate GOC as a GOC**

QIC is a GOC.
