MAJOR SPORTS FACILITIES REGULATION 2002

[as amended by all amendments that commenced on or before 30 May 2003]

1 Short title

This regulation may be cited as the *Major Sports Facilities Regulation 2002*.

2 Declaration of major sports facility—Act, s 4

(1) Each of the following is a major sports facility for the Act—

- (a) Brisbane Cricket Ground;
- (b) Brisbane Entertainment Centre;
- (c) Queen Elizabeth II Complex;
- (d) Sleeman Sports Centre;
- (e) the facility called ‘Suncorp Stadium’ (formerly called ‘Suncorp Metway Stadium’), as described in the schedule.

(2) The declaration under subsection (1)(e) takes effect at 5.00 p.m. on 30 May 2003.

3 Prescribed day for expiry of Act, pt 5

The prescribed day for section 53(b) of the Act is 30 May 2003.
