Major Sports Facilities Regulation 2002

1 Short title

This regulation may be cited as the *Major Sports Facilities Regulation 2002*.

2 Declaration of major sports facility—Act, s 4

- (1) Each of the following is a major sports facility for the Act—
 - (a) Brisbane Cricket Ground;
 - (b) Brisbane Entertainment Centre;
 - (c) Queen Elizabeth II Complex;
 - (d) Sleeman Sports Centre;
 - (e) the facility called ‘Suncorp Stadium’ (formerly called ‘Suncorp Metway Stadium’), as described in the schedule;
 - (f) Willows Sports Complex, incorporating Dairy Farmers Stadium.
- (2) The declaration under subsection (1)(f) takes effect on 4 January 2004.
