PART 1—PRELIMINARY

1 Short title

This regulation may be cited as the *Coastal Protection and Management (Coastal Management Districts) Regulation 2003*.

2 Commencement

This regulation commences on 29 December 2003.

PART 2—COASTAL MANAGEMENT DISTRICTS

3 Coastal management districts

Each of the areas described in the schedule—

- (a) is a coastal management district; and
- (b) has the name stated, in the schedule, for the district; and
- (c) has the coastal building lines stated, in the schedule, for the district.
