## **1 Short title**

This notice may be cited as the *Electrical Safety (Codes of Practice) Notice 2002*.

## **2 Making codes of practice—sch 1**

- (1) The documents mentioned in schedule 1 have been made as codes of practice.<sup>1</sup>
- (2) Each code of practice commences and expires as mentioned in schedule 1.

## **3 Amended codes of practice—sch 2**

## **4 Repealed codes of practice—sch 3**

- (1) The codes of practice mentioned in schedule 3 are repealed.<sup>3</sup>
