## **Acquisition of Land Regulation 2003**

[as amended by all amendments that commenced on or before 1 July 2007]

### **1 Short title**

This regulation may be cited as the *Acquisition of Land Regulation 2003*.

### **2 Fee—Act, s 9**

The fee payable for an application under section 9<sup>1</sup> of the Act is—

- (a) if the application relates to only 1 parcel of land—\$131.70; or
- (b) if the application relates to more than 1 parcel of land—\$131.70 plus \$39.10 for each additional parcel of land.

### **3 Repeal**

The *Acquisition of Land Regulation 1993* is repealed.
