# Legal Profession (Transitional) Regulation 2007

[reprinted as in force on 1 July 2007]

## 1 Short title

This regulation may be cited as the *Legal Profession (Transitional) Regulation 2007*.

## 2 Commencement

This regulation commences on 1 July 2007.

## 3 Costs of assessment

- (1) A costs assessor must decide the costs of a costs assessment.
- (2) Unless the costs assessor otherwise orders, the law practice to which the legal costs are payable or were paid must pay the costs of the costs assessment if—
  - (a) on the assessment, the legal costs are reduced by 15% or more; or
  - (b) the costs assessor is satisfied the law practice failed to comply with part 3.4, division 3, of the Act.
- (3) Unless the costs assessor otherwise orders, if the law practice is not, under subsection (2), liable to pay the costs of the costs assessment, the costs of the assessment must be paid by the party ordered by the costs assessor to pay those costs.

## 4 Declaration that regulation is a transitional regulation—Act, s 751

This regulation is a transitional regulation.

## 5 Expiry of regulation

This regulation expires 1 year after the commencement of section 751 of the Act.
