This regulation may be cited as the *Personal Property Securities (Ancillary Provisions) Regulation 2011.* 

### 2 Commencement

- (1) Section 3 and the schedule, part 1 commence immediately after the commencement of the Act, chapter 3, part 1.
- (2) Section 4 and the schedule, part 2 commence immediately after the commencement of the Act, chapter 3, part 3.
- (3) Section 5 and the schedule, part 3 commence immediately after the commencement of the Act, chapter 3, part 4.
