# Land Sales Regulation 2000

[as amended by all amendments that commenced on or before 1 July 2014]

## **1 Short title**

This regulation may be cited as the *Land Sales Regulation 2000*.

## **2 Fees**

The fees payable under the Act for a matter are in schedule 1.

## **3 Definitions**

The dictionary in schedule 3 defines terms used in this regulation.

## **4 Period for giving a registrable instrument**

The period mentioned in schedule 2 for a proposed lot is prescribed for the Act, section 28(1).
