1 Short title

This quota declaration may be cited as the *Fisheries (Spanner Crab Fishery) Quota Declaration 2015*.

3 **Annual quota for commercial spanner crab fishery—Act, s 44**

(1) *For an ITQ year, the annual quota for spanner crabs that may be taken from the commercial spanner crab fishery (managed area A) is 1631t.*

(2) *In this section—*

commercial spanner crab fishery (managed area A) see the Fisheries Regulation 2008, section 600A.

ITQ year see the Fisheries Regulation 2008, schedule 11, part 2.
