An Act to regulate the operation of tow trucks to remove motor vehicles from private property and damaged and seized motor vehicles, to amend this Act, the *Photo Identification Card Act 2008*, the *Police Powers and Responsibilities Act 2000*, the *State Penalties Enforcement Act 1999*, the *Transport Operations (Passenger Transport) Act 1994*, the *Transport Operations (Road Use Management) Act 1995* and the *Transport Planning and Coordination Act 1994* for particular purposes, and to repeal the *Tow Truck Act 1973*

1 Short title 4

This Act may be cited as the *Tow Truck Act 2023*. 5

2 Commencement 6

This Act commences on a day to be fixed by proclamation. 7

3 Main purposes of Act 8

(1) The main purposes of this Act are— 9

(a) to facilitate best practice in the tow truck industry by 10
providing a balanced framework for regulating the 11
operation of tow trucks to carry out regulated towing; 12
and 13

(b) to protect the public by ensuring tow trucks carrying out 14
regulated towing are operated in a safe, competent and 15
professional way and at a reasonable cost to consumers; 16
and 17

(c) to protect public safety and the safety of the road 18
network through ensuring the following in regulated 19
areas— 20

(i) the safe and efficient removal of motor vehicles 21
damaged in an incident from the scene of the 22
incident and seized motor vehicles from the place 23
of seizure; 24

(ii)	the safe removal of motor vehicles parked on private property.	1 2
(2)	The main purposes are achieved by—	3
(a)	requiring persons who conduct tow truck businesses, and persons involved in operating tow trucks to carry out regulated towing, to hold an accreditation; and	4 5 6

8 Meaning of *regulated towing*

Regulated towing is—

- (a) the towing of a motor vehicle that is damaged in an incident in a regulated area from the scene of the incident; or
- (b) the towing of a motor vehicle that is seized in a regulated area from the place of seizure; or
- (c) private property towing.

9 Meaning of *private property towing*

Private property towing is the towing of a motor vehicle parked on private property in a regulated area from the property if the owner of the vehicle has not expressly requested or directed the towing of the vehicle from the property.

- (1) In deciding whether a person is an appropriate person to hold or continue to hold an accreditation, the chief executive must have regard to the following matters— 7

- (1) A person may apply to the chief executive for an accreditation. 13

- (2) The application must— 15
- (a) be made in the way prescribed by regulation; and 16
- (b) be accompanied by the fee prescribed by regulation; and 17
- (c) include or be accompanied by the information prescribed by regulation. 18

18 Deciding applications 20

- (1) The chief executive must consider the application and decide to— 21

- (a) approve the application; or 23
- (b) refuse the application. 24
- (2) In deciding the application, the chief executive— 25
- (a) must consider the matters prescribed by regulation; and 26

19 Giving accreditation documents and information notices

- (1) If the decision is to approve the application, the chief executive must give the applicant an accreditation document that states the following—
- (a) the type of accreditation that is being given;
- (b) the day the accreditation document is given;
- (c) the name of the holder of the accreditation;
- (d) the day the accreditation stops having effect (the *expiry day*);
- (e) the conditions imposed on the accreditation under section 20;
- (f) for an operator accreditation—
- (i) the name and business address of the tow truck business the holder is authorised to conduct under the accreditation (the *authorised tow truck business*); and
- (ii) any premises that may be used as a holding yard under the accreditation (each an *authorised holding yard*); and
