<b>Part 1 Preliminary</b>	2
<b>1 Short title</b>	3
This Act may be cited as the <i>State Emergency Service Act 2023</i> .	4 5
<b>2 Commencement</b>	6
This Act commences on a day to be fixed by proclamation.	7
<b>3 Main purpose of Act</b>	8
The main purpose of this Act is to establish the State Emergency Service to provide—	9 10
(a) emergency services in the State; and	11
(b) other related services to government entities and the community.	12 13
<b>4 Act binds all persons</b>	14
(1) This Act binds all persons, including the State and, to the extent the legislative power of the Parliament permits, the Commonwealth and the other States.	15 16 17
(2) However, the Commonwealth or a State can not be prosecuted for an offence against this Act.	18 19
<b>5 Definitions</b>	20
The dictionary in schedule 1 defines particular words used in this Act.	21 22

  - (c) the establishment of management and support services for the SES; and 6

  - (d) the development of policies to help the SES perform its functions effectively and efficiently including, for example, policies about training SES members; and 8

  - (e) the giving of directions and guidance to the SES chief officer, local controllers, SES commanders and SES members; and 11

  - (f) the performance of any other function relating to the SES that is given to the commissioner under this Act or another Act. 14

**10 Commissioner may make code of practice** 17

- (1) The commissioner may make a code of practice about any of the following— 18

  - (a) the conduct or practice of SES members; 20
  - (b) the operation of SES units, to provide guidance to SES members; 21

  - (c) another matter the commissioner considers appropriate for the effective performance of the functions of— 23  
24
    - (i) SES members; or 25
    - (ii) SES units. 26
- (2) The commissioner must, as soon as practicable after making a code of practice— 27

  - (a) give a copy of the code to each SES unit; and 29
  - (b) publish the code on the department’s website. 30

- 20 Commissioner to insure SES volunteers** 1
- (1) The commissioner must enter into a contract of insurance with WorkCover or another entity to insure SES volunteers. 2  
3
- (2) The contract of insurance must cover an SES volunteer while the person is— 4  
5
- (a) performing a function relating to the SES in their capacity as an SES member; or 6  
7
- (b) involved in another activity, including training, related to the carrying out of a function of the SES or disaster operations under the *Disaster Management Act 2003*. 8  
9  
10
- (3) In this section— 11
- WorkCover** means WorkCover Queensland established under the *Workers' Compensation and Rehabilitation Act 2003*. 12  
13
- 21 Suspension of SES local government employee or SES volunteer** 14  
15
- (1) This section applies in relation to a person who is— 16
- (a) an SES employee performing an SES function as an employee of a local government; or 17  
18
- (b) an SES volunteer. 19
- (2) The commissioner may, by notice to the person, suspend the person from duty as an SES member if the commissioner reasonably believes— 20  
21  
22
- (a) the person would, if the person were an employee under the *Public Sector Act 2022*, be liable to be disciplined under a disciplinary law within the meaning of that Act; or 23  
24  
25  
26
- (b) the proper and efficient management of the SES might be prejudiced if the person is not suspended. 27  
28
- (3) However, before suspending the person, the commissioner must consider all reasonable alternative actions available to the commissioner in relation to the person. 29

- (4) The notice must state when the suspension starts and ends. 6
- (5) The commissioner may, by notice to the person, extend or further extend the period of suspension before the period ends if the commissioner reasonably believes the circumstances mentioned in subsection (2)(a) or (b) still exist. 7

- (6) The commissioner must ensure the matter is investigated promptly to ensure the timely resolution of the suspension. 11  
12
- (7) The commissioner may cancel the suspension at any time. 13

## **Division 4 Arrangements for police officers** 14

### **22 Secondment of police officers** 15

- (1) The SES chief officer may arrange with the commissioner for the services of police officers to be made available to the SES. 16  
17
- (2) The arrangement is not effective unless it has been approved by the Minister. 18  
19
- (3) A police officer whose services are seconded to the SES under this section— 20  
21
- (a) is subject to the direction and control of the SES chief officer in relation to the performance of SES functions; but 22  
23  
24
  - (b) continues to be a police officer for all purposes and to have the functions and powers of a police officer without being limited to the performance of SES functions. 25

**24 Local controller of SES unit** 3

- (1) For each SES unit, the commissioner must appoint an SES 4  
member to be the local controller of the unit. 5
- (2) The appointment must be made by notice given to the SES 6  
member. 7
- (3) The commissioner may appoint an SES member as the local 8  
controller for an SES unit for a local government area only 9  
if— 10
  - (a) the local government for the local government area has 11  
nominated the member for appointment as the local 12  
controller; and 13
  - (b) the commissioner is satisfied the member has the 14  
necessary expertise or experience to perform the 15  
functions of a local controller. 16
- (4) A local controller holds office on any conditions the 17  
commissioner considers appropriate and stated in the notice 18  
given to the controller. 19

**25 Functions of local controller** 20

- (1) The local controller for an SES unit is responsible for 21  
maintaining the operational effectiveness of the unit by 22  
ensuring— 23
  - (a) the SES members in the unit have the necessary skills to 24  
perform their roles in the unit competently; and 25
  - (b) the unit's equipment is maintained in an appropriate 26  
condition; and 27
  - (c) the unit performs its functions and other activities in a 28  
way that is consistent with departmental policies about 29  
the performance of an SES unit's functions and other 30  
activities; and 31

- 
- (d) the unit performs its functions in compliance with—
    - (i) this Act and any other applicable Act or law; and
    - (ii) any operational permits and approvals applying to an SES unit; and
  - (e) the SES members in the unit comply with any direction given by the commissioner, the SES chief officer or an SES commander.
- (2) In performing the functions under subsection (1), the local controller must give effect to any direction given by the commissioner or the SES chief officer.
  - (3) A local controller of an SES unit may delegate the local controller's functions under this section to another SES member.

**26 SES commanders**

- (1) The commissioner may, by notice to a person, appoint the person as an SES commander for a group of SES units to coordinate the performance of SES functions by the group.
- (2) The commissioner may appoint a person as an SES commander only if—
  - (a) the person is an SES member; and
  - (b) the commissioner is satisfied the member is appropriately qualified to perform the functions of an SES commander.
- (3) An SES commander holds office on any conditions the commissioner considers appropriate and stated in the notice given to the commander.
- (4) The commissioner must advise the chairperson of each relevant local group and the relevant district disaster coordinator that an SES commander has been appointed.
- (5) The commissioner may terminate the appointment of an SES commander for a group of SES units if the commissioner

(6) The commissioner must advise the chairperson of each  
relevant local group and the relevant district disaster  
coordinator of the termination. 3

## **27 Functions of SES commanders** 21

(1) An SES commander for a group of SES units for local  
government areas has the following functions— 22

(a) to coordinate the performance of SES functions in the  
local government areas when resources of the SES from  
outside the local government areas are made available to  
the group; 24

(b) to provide advice to local controllers of the SES units  
about— 28

(i) SES functions; and 30

(ii) managing the safety and fatigue of the members of  
the SES units; and 31

- (iii) logistical and financial matters; 1
- (c) to perform other functions agreed between the SES 2  
commander and the local disaster coordinator for the 3  
relevant local group; 4
- (d) to give effect to any direction given by the 5  
commissioner or SES chief officer. 6
- (2) In performing the SES commander's functions, the 7  
commander must have regard to— 8
- (a) the advice of the local disaster coordinator for a relevant 9  
local group; and 10
- (b) any applicable disaster management plans. 11
- (3) In this section— 12
- disaster management plan* has the meaning given by the 13  
*Disaster Management Act 2003*. 14
- local disaster coordinator* has the meaning given by the 15  
*Disaster Management Act 2003*. 16
- local group* has the meaning given by the *Disaster* 17  
*Management Act 2003*. 18
- relevant local group* means the local group for the local 19  
government area for an SES unit in the group of SES units. 20

## **Part 3 Authorised rescue officers** 21

### **Division 1 Appointment** 22

#### **28 Appointment** 23

- (1) The commissioner may appoint any of the following persons 24  
as an authorised rescue officer— 25
- (a) an SES member; 26

- (b) a person who performs a function similar to an emergency-related SES function under a law of another State or country; 1

- (c) a member of a class of persons prescribed by a regulation. 4

- (2) However, the commissioner may appoint a person as an authorised rescue officer only if satisfied the person has the necessary expertise or experience to be an authorised rescue officer. 6  
7  
8  
9
- 29 Appointment conditions and limit on powers** 10
- (1) An authorised rescue officer holds office on any conditions stated in— 11  
12
- (a) the officer’s instrument of appointment; or 13
- (b) a signed notice given to the officer; or 14
- (c) a regulation. 15
- (2) The instrument of appointment, a signed notice given to the officer or a regulation may limit the officer’s powers under this Act. 16  
17  
18
- (3) In this section— 19
- signed notice* means a notice signed by the commissioner. 20
- 30 Resignation** 21
- An authorised rescue officer may resign by signed notice given to the commissioner. 22  
23
- 31 Issue of identity card** 24
- (1) The commissioner must issue an identity card to each authorised rescue officer. 25

- (2) The identity card must— 27
- (a) contain a recent photo of the officer; and 28

	(b) identify the person as an authorised rescue officer under this Act; and	1 2
	(c) state an expiry date for the card.	3

**35 Powers for performing emergency-related SES function** 4

- (1) This section applies to an authorised rescue officer for performing an emergency-related SES function. 5  
6
- (2) The authorised rescue officer may take reasonable steps to protect— 7  
8
- (a) a person who is trapped, or endangered in another way, in a place; or 9  
10
  - (b) the officer or another person from danger, potential danger or assault. 11  
12
- (3) Without limiting subsection (2), each of the following is a reasonable step— 13  
14
- (a) entering a place under section 36; 15
  - (b) searching any part of a place; 16
  - (c) opening a container or other thing; 17
  - (d) removing any thing from a place; 18
  - (e) destroying or damaging premises, a vehicle, container or other thing; 19  
20
  - (f) taking into or onto a place the equipment, persons or materials the authorised rescue officer reasonably requires to exercise a power under this section; 21  
22  
23
  - (g) giving a person a direction to leave, or not to enter, an area in or near a place if the authorised rescue officer reasonably considers the direction is necessary to protect a person’s life or health; 24  
25  
26  
27
  - (h) making a requirement of a person at or near a place to give the authorised rescue officer reasonable help to exercise the officer’s powers under paragraphs (a) to (f). 28  
29  
30
- (4) When giving a direction or making a requirement mentioned in subsection (3)(g) or (h), the authorised rescue officer must 31  
32



warn the person it is an offence to fail to comply with the direction or requirement unless the person has a reasonable excuse.

*Notes—*

  - (a) tell the occupier the purpose of the entry;
  - (b) seek the consent of the occupier to the entry;
  - (c) tell the occupier the officer is permitted under this Act to enter the place without the occupier’s consent.
- (3) Subsection (2) does not require the authorised rescue officer to take a step the officer reasonably believes may frustrate or otherwise hinder the officer’s ability to give the protection mentioned in section 35(2).
