**AMENDMENT OF THE TRANSPORT OPERATIONS (MARINE  
SAFETY) REGULATION 1995**

**Short title**

1. This regulation may be cited as the *Department of Transport (Variation of Fees) Regulation (No. 2) 1996*.

**Commencement**

2. This regulation commences on 1 July 1996.

### AMENDMENT OF THE TRANSPORT OPERATIONS (MARINE SAFETY) REGULATION 1995

- (a) for a ship not over 4.5 m—\$39.50; or
- (b) for a ship over 4.5 m—\$68.00.

‘(4) The boating facilities component for a recreational ship is—

- (a) for a ship not over 10 m—\$7.00 for each metre or part of a metre; or
- (b) for a ship over 10 m but not over 35 m—\$70.00 plus \$11.50 for each metre, or part of a metre, over 10 m; or
- (c) for a ship over 35 m—\$360.00.

‘(5) The drive fee component for a recreational ship for which a licence to operate the ship as its master is required is \$5.70.’.

#### 2. Schedule 7, section 4(3) to (7)—

‘(3) The registration component for a commercial ship is—

- (a) for a ship not over 4.5 m—\$39.50; or
- (b) for a ship over 4.5 m—\$68.00.

‘(4) The boating facilities component for a commercial ship is as follows—

- (a) for a ship over than 10 m—\$7.00 for each metre or part of a metre;

‘**(5)** The compliance monitoring component for class 1B, C, D and E ships and class 2B, C, D and E ships is as follows—

- (a) for a ship not over 7 m—\$100.00;
- (b) for a ship over 7 m but not over 10 m—\$245.00;
- (c) for a ship over 10 m but not over 15 m—\$305.00;
- (d) for a ship over 15 m but not over 20 m—\$375.00;
- (e) for a ship over 20 m but not over 25 m—\$430.00;
- (f) for a ship over 25 m but not over 35 m—\$485.00;
- (g) for a ship over 35 m but not over 50 m—\$575.00;
- (h) for a ship over 50 m but not over 75 m—\$620.00;
- (i) for a ship over 75 m but not over 100 m—\$710.00;
- (j) for a ship over 100 m—\$885.00.

‘**(6)** The compliance monitoring component for class 1F ships is as follows—

- (a) for a ship not over 7 m—\$38.50;
- (b) for a ship over 7 m but not over 10 m—\$65.00;
- (c) for a ship over 10 m but not over 15 m—\$96.00;
- (d) for a ship over 15 m but not over 20 m—\$130.00;
- (e) for a ship over 20 m but not over 25 m—\$190.00;
- (f) for a ship over 25 m but not over 35 m—\$225.00;
- (g) for a ship over 35 m—\$255.00.

‘(7) The compliance monitoring component for commercial hovercraft is as follows—

- (a) for a hovercraft over 5 m—\$96.00;
- (b) for a hovercraft over 5 m but not over 7.5 m—\$130.00;
- (c) for a hovercraft over 7.5 m but not over 10 m—\$200.00;
- (d) for a hovercraft over 10 m but not over 15 m—\$260.00;
- (e) for a hovercraft over 15 m but not over 20 m—\$395.00;
- (f) for a hovercraft over 20 m but not over 30 m—\$525.00;
- (g) for a hovercraft over 30 m—\$655.00.’.

- (viii) for a ship over 100 m—\$885.00.’.

- (e) engineer class 3—\$195.00;
