**‘1A Bayview Conservation Park**

- ‘(1) The trustees of the Bayview Conservation Park have, for the conservation park, the powers of the chief executive under chapters 1 and 2.
- ‘(2) However, the trustees do not have power—
- (a) to charge a fee for entry to the park; or
  - (b) to grant any of the following—
    - (i) an Aboriginal tradition or Island custom authority;
    - (ii) a permit to take, use, keep or interfere with cultural or natural resources.’.
