## **Part 1 Preliminary**

### **1 Short title**

This regulation may be cited as the *Nature Conservation Legislation Amendment Regulation (No. 3) 2006*.

### **2 Purpose of regulation**

- (1) The purpose of this regulation is to revoke the dedication of the whole of the forest reserves mentioned in section 4(1) and a part of the forest reserve mentioned in section 4(2) to allow the forest reserve or part (each a *revoked forest reserve area*) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as a protected area, or part of a protected area, under part 3.
