**1 Short title**

This regulation may be cited as the *Water Amendment Regulation (No. 1) 2007*.

**2 Regulation amended**

This regulation amends the *Water Regulation 2002*.

**3 Amendment of s 49 (Destroying vegetation in a watercourse, lake or spring—Act, s 814)**

(1) Section 49(1)(f) and (g)—

*omit, insert—*

‘(f) the document called ‘Guideline—Activities in a watercourse, lake or spring carried out by an entity’, approved by the chief executive.

(2) Section 49(2) and (3)—

**4 Amendment of s 50 (Excavating in a watercourse, lake or spring—Act, s 814)**

(1) Section 50(1)(e) to (g)—

‘(e) the document called ‘Guideline—Activities in a watercourse, lake or spring carried out by an entity’, approved by the chief executive.’.

(2) Section 50(2) and (3)—

*omit.*

**5 Amendment of s 51 (Placing fill in a watercourse, lake or spring—Act, s 814)**

(1) Section 51(1), from ‘if’—

*omit, insert—*

‘if the placing is carried out under—

- (a) a lease or authority to prospect under the *Petroleum Act 1923*; or
- (b) a licence, petroleum lease or authority to prospect under the *Petroleum and Gas (Production and Safety) Act 2004*; or
- (c) a licence under the *Fossicking Act 1994*; or
- (d) an environmental authority (mining activities) under the *Environmental Protection Act 1994*; or
- (e) the document called ‘Guideline—Activities in a watercourse, lake or spring carried out by an entity’, approved by the chief executive.’.

- (2) Section 51(2) and (3)—

*omit.*
