omit, insert—

‘TR 165 on plan FTY1722 excluding lot 7 on DP189923’.

Part 3 Amendment of Nature Conservation (Forest Reserves) Regulation 2000

4 Regulation amended in pt 3

This part amends the *Nature Conservation (Forest Reserves) Regulation 2000*.

5 Amendment of s 2 (Dedication of forest reserves)

Section 2(1), from ‘State forest’ to ‘Land Act reserve’—
omit, insert—

‘Land Act reserve, State forest, timber reserve or unallocated State land’.

6 Amendment of schedule (Forest reserves)

Schedule, entry for Nerang Forest Reserve—
omit, insert—

‘Nerang Forest Reserve

Lot 571 on AP6293 and lot 1 on AP4848, situated in the County of Ward, containing an area of about 1659ha’.

8 Amendment of sch 2 (National parks)

omit.

insert—

‘Crater Lakes National Park	Lot 398 on NPW346, lot 1 on AP14393 and lot 202 on plan NPW175, other than the part within the area shown and described on plan R11-270LA as area required from lot 202 on plan NPW175 and the parts within the area shown and described on drawing CNS05/048(A) as road to be opened, situated in the County of Nares, containing an area of about 974ha
Kuranda National Park	Lots 1 and 2 on SP167725 and lot 63 on plan NPW931 Sh 1, other than lot A on plan DA811477 and lot B on plan NR811478 to the extent lots A and B are located within the land shown as lot 1229 on AP6357, situated in the counties of Dagmar and Nares, containing an area of about 26880ha
Moreton Island National Park	Lot 36 on plan NPW662 and lot 46 on SP135368 situated in the County of Stanley, containing an area of about 16910ha’.

9 Amendment of sch 5 (Nature refuges)

Schedule 5—

insert—

‘SEQWater Nature Refuge	The lots or parts of lots situated in the counties of Canning, Cavendish and Stanley, containing an area of about 8195.41ha, shown on plan PA336 as SEQWater Nature Refuge’.
