This regulation may be cited as the *Superannuation (State Public Sector) Amendment of Deed Regulation (No. 2) 2007*.

Section 68, definition *preservation cashing condition*, paragraph (b)(iii)—

omit, insert—
‘(iii) turns 65 years; or’.

5 Amendment of s 363 (Agreement or court order for member with less than 8 years service at the operative time)

Section 363(3), ‘of the State Public Sector Superannuation Fund’—
omit.

6 Amendment of s 364 (Agreement or court order for member with at least 8 years service at the operative time)

Section 364(3), 'of the State Public Sector Superannuation Fund'—

omit.

7 Amendment of s 365 (Agreement or court order for member with at least 8 years service after the operative time)

Section 365(5)(b)(ii), 'of the State Public Sector Superannuation Fund'—

omit.

8 Amendment of s 386 (Payment of lump sum)

Section 386(4), 'of the State Public Sector Superannuation Fund'—

omit.
