1 Short title

This plan may be cited as the *Water Resource (Mary Basin) Amendment Plan (No. 1) 2007*.

2 Plan amended

This plan amends the *Water Resource (Mary Basin) Plan 2006*.

Section 37(5), definition *water supply schemes*—
insert—

‘(d) the Teddington Weir Water Supply Scheme.’.

4 Amendment of s 49 (Water allocations to be managed under resource operations licences)

Section 49—
insert—

‘(d) Teddington Weir Water Supply Scheme.’.

5 Amendment of s 51 (Water entitlements to replace local government authorities)

(1) Section 51(1), ‘section 1037’—

omit, insert—

‘section 1037 or 1037A’.

(2) Section 51(1)(a), ‘Addington’—

omit, insert—

‘Addlington’.

(3) Section 51(1)(d) to (f)—

 - (a) the monthly supplemented water sharing index be at least 88%; and
 - (b) the extent to which it is less than 93% be minimised.’.

‘(c) the Teddington Weir Water Supply Scheme from Tallegalla Weir (including the ponded area) at AMTD 37.5km on Tinana Creek downstream to Teddington Weir (including the ponded area) on Tinana Creek; and’.

(4) Schedule 11, section 3(c), ‘are’—

omit, insert—

‘area’.

‘Schedule 11A Formula

sch 12, definition *annual proportional flow deviation*

$$APFD = \sum_{j=1}^p \frac{\sqrt{\sum_{i=1}^{12} \left(\frac{c_{ij} - n_{ij}}{\bar{n}_i} \right)^2}}{p}$$

where—

p means the number of years.

c_{ij} means the modelled flow for month i in year j .

n_{ij} means the modelled natural flow for month i in year j .

\bar{n}_i means the modelled natural flow for month i across p years.’.

‘***annual proportional flow deviation***, for a node, means the statistical measure of changes to flow season and volume in the simulation period, at the node, calculated using the formula in schedule 11A.

water year, for water taken under a water entitlement, means the water year for the resource operations plan.’.
