Part 1 Preliminary

1 Short title

This regulation may be cited as the *Government Owned Corporations Amendment Regulation (No. 1) 2008*.

2 Regulation amended in pt 2

This part amends the *Government Owned Corporations Regulation 2004*.

3 Insertion of new s 8A

Part 3, division 1—

insert—

‘8A Change of name to Cairns Ports

‘(1) On the commencement of this section, Cairns Port Authority continues in existence under the name Cairns Ports.

‘(2) Subsection (1) does not affect the operation of sections 6(2), 7 and 8(1).’.

4 Insertion of new s 11A

Part 3, division 2—

insert—

‘11A Change of name to Gladstone Ports Corporation

- ‘(1) On the commencement of this section, Central Queensland Ports Authority continues in existence under the name Gladstone Ports Corporation.
- ‘(2) Subsection (1) does not affect the operation of sections 9(2), 10 and 11(1).’.

5 Insertion of new s 14A

Part 3, division 3—

insert—

‘14A Change of name to Mackay Ports

- ‘(1) On the commencement of this section, Mackay Port Authority continues in existence under the name Mackay Ports.
- ‘(2) Subsection (1) does not affect the operation of sections 12(2), 13 and 14(1).’.

6 Insertion of new s 29

Part 3, division 7—

insert—

‘29 Change of name to Port of Townsville

- ‘(1) On the commencement of this section, Townsville Port Authority continues in existence under the name Port of Townsville.
- ‘(2) Subsection (1) does not affect the operation of sections 26(2), 27 and 28(1).’.

7 Regulation amended in pt 3

This part amends the *Transport Infrastructure (Ports) Regulation 2005*.

8 Amendment of sch 2 (Port management)

Schedule 2, entries for ports of Cairns, Gladstone, Mackay and Townsville—

omit, insert—

‘Cairns	Cairns Ports
Gladstone	Gladstone Ports Corporation
Mackay	Mackay Ports
Townsville	Port of Townsville’.
