Part 1 Preliminary

1 Short title

This regulation may be cited as the *Gambling Legislation Amendment Regulation (No. 2) 2008*.

2 Commencement

Section 4 commences on 1 January 2009.

Part 2 Amendment of Gaming Machine Regulation 2002

3 Regulation amended in pt 2

This part amends the *Gaming Machine Regulation 2002*.

4 Replacement of s 15 (Periods when gaming must not be conducted—Act, s 235)

Section 15—

omit, insert—

‘15 Periods when gaming must not be conducted—Act, s 235

‘For section 235(1)(c) of the Act, the following periods are prescribed—

- (a) for Anzac Day—before 1p.m.;
- (b) for Good Friday—all day;
- (c) for Christmas Day—all day;
- (d) for any other day—before 10a.m., other than to the extent of any part of the period, that is part of the licensee’s hours of gaming fixed for the licensee’s

licensed premises by the commission, that started on the previous day.’.

5 Amendment of s 53 (Percentage of major facilities levy—Act, s 316B)

Section 53, heading, ‘major facilities levy’—

omit, insert—

‘health services levy’.

6 Amendment of s 55 (Crediting of payments—Act, s 319)

(1) Section 55(1)(a), ‘major facilities levies’—

omit, insert—

‘health services levies’.

(2) Section 55(2), ‘major facilities levy’—

omit, insert—

‘health services levy’.

7 Amendment of sch 1 (Prescribed entities)

Schedule 1, ‘Independent Gambling Authority, South Australia’, first mention—

omit.

8 Regulation amended in pt 3

This part amends the *Lotteries Regulation 2007*.

9 Amendment of s 9 (Calculation of monthly gross revenue)

Section 9(1), formula, definition A—

omit, insert—

‘A means the total amount (the *total receipts*) paid for tickets (excluding mail order fees) sold by the lottery operator, and the lottery agents for the lottery operator, for all drawings of the classified lottery that take place in the month.’

10 Amendment of sch 1 (Entities)

Schedule 1, ‘Independent Gambling Authority, South Australia’, first mention—

omit.
