This regulation may be cited as the *Casino Control Amendment Regulation (No. 1) 2009*.

2 Commencement

This regulation commences on 1 July 2009.

This regulation amends the *Casino Control Regulation 1999*.

‘19A Percentage determined for premium junket revenue—Act, s 51(4)

‘For the Act, section 51(4), the percentage determined for premium junket revenue for an associated agreement for a casino licence is 10%.

‘19B Percentage for community investment fund—Act, s 51A(3)

‘For the Act, section 51A(3), the percentage is 8.5%.

‘19C Casino Community Benefit Fund—Act, s 52(8)

‘For the Act, section 52(8), a single trust deed may apply to the amounts apportioned under the Act, section 52(4) for the following casino licences—

- (a) the casino licence relating to the agreement made under the *Brisbane Casino Agreement Act 1992*;
- (b) the casino licence relating to the agreement made under the *Jupiters Casino Agreement Act 1983*.’.
