Part 1 Preliminary

1 Short title

This regulation may be cited as the *Transport Infrastructure Legislation Amendment Regulation (No. 1) 2009*.

2 Commencement

This regulation commences on 1 October 2009.

3 Regulation amended

This part amends the *Transport Infrastructure (Ports) Regulation 2005*.

4 Amendment of s 3A (Transfer of management of a port—Act, s 271(1))

(1) Section 3A(1), from ‘from’ to ‘Limited’—

omit, insert—

‘from Port of Brisbane Corporation Limited to Gladstone Ports Corporation Limited’.

(2) After section 3A(1)—

insert—

Note—

The management of the port of Bundaberg had previously been transferred from the Bundaberg Port Authority to the Port of Brisbane Corporation Limited by the *Transport Infrastructure (Ports) Amendment Regulation (No. 1) 2007*, section 4.’.

Cairns Ports Limited ACN 131 836 014 changed its name to Far North Queensland Ports Corporation Limited on 2 July 2009.’.
