## Part 1 Preliminary

### 1 Short title

This regulation may be cited as the *Forestry and Nature Conservation Legislation Amendment Regulation (No. 4) 2009*.

### 2 Main purpose of regulation

- (1) The main purpose of this regulation is to revoke the dedication of the whole or part of the forest reserves mentioned in section 6(1) to allow the whole or part of the forest reserves (each a *revoked forest reserve area*) to become a protected area.
- (2) Each revoked forest reserve area is dedicated as a protected area under part 4.
