1 Short title

This regulation may be cited as the *Gaming Machine Amendment Regulation (No. 1) 2009*.

2 Commencement

(1) This regulation, other than section 9, commences on 30 November 2009.

(2) Section 9 commences immediately after the commencement of the *Queensland Civil and Administrative Tribunal (Jurisdiction Provisions) Amendment Act 2009*, chapter 5, part 35.

south-east region means the area of the Brisbane and Moreton statistical divisions defined in the classification document.

western region means the area of the Central West, Darling Downs, North West and South West statistical divisions defined in the classification document.'
