- 2 The following provisions commence on **1 April 2010**—

  - sections 81, 83 to 85, 87 to 89, 92, 94(1) and (4), 95, 96(1), 97(1), (2), (4) and (5), 98(1) and (2), 99, 103, 108(6) and (7), 114, 116(4), 120(1), (3) and (5), 124(3) and (4), 125(1) to (5), 126 to the extent it inserts section 105D, 131, 132, 134, 135, 137, 139, 140(1), (2) and (4), 141 other than to the extent it inserts section 114B, 142(1), (3), (4) and (7), 143, 144(3) and (5), 145(2) to (4), 148, 150, 151, 156 to the extent it inserts part 16, division 5, subdivisions 1 to 3 and 5, 157, 159 and 160(1) to (3)
  - part 8
  - sections 172, 173(3), 175(3), 175(6) to the extent it inserts subsection (8), 176 to the extent it inserts section 15B, 189(3), 189(4) to the extent it inserts section 75(7), 190, 192 to 195, 197(1) and (2), 198, 199, 200 other than to the extent it inserts sections 333 to 338, 201(1) to the extent it omits definition *imprisonment order*, 201(2) to the extent it inserts definitions *children's commissioner*, *Commissioner's Act* and *imprisonment order*, and 201(3), (4) and (7)
  - parts 10 and 11
  - parts 13 to 15
  - part 16 other than section 240
  - section 240 other than to the extent it inserts section 258(1)(b)
  - parts 18 and 19
  - schedules 1 to 3.
