### **1 Short title**

This regulation may be cited as the *Land Title and Other Legislation Amendment Regulation (No. 1) 2012*.

### **2 Commencement**

  - (f) section 9;
  - (g) section 10(1) to (3).
- (2) The remaining provisions commence on 1 December 2012.
