**1 Short title**

This regulation may be cited as the *Major Events (Motor Racing Events) (Townsville 400) Amendment Regulation 2020*.

**2 Commencement**

This regulation commences on 3 August 2020.

**3 Regulation amended**

This regulation amends the *Major Events (Motor Racing Events) Regulation 2015*.

**4 Replacement of pt 2 (Townsville 400)**

**Part 2 Townsville 400**

**3 Townsville 400 is a major event—Act, s 12**

For section 12(1) of the Act, the V8 Supercars motor racing event known as the Townsville 400 to be held in 2020 is prescribed as a major event.

**4 Major event organiser for Townsville 400—Act, s 12**

For section 12(2)(a) of the Act, V8 Supercars Australia Pty Ltd ACN 077 053 484 is prescribed as the major event organiser for the Townsville 400.

**5 Major event area for Townsville 400—Act, s 12**

For section 12(2)(b) of the Act, the major event area prescribed for the Townsville 400 is the area

---

surrounding the Townsville Civic Theatre shown on the map in schedule 1 as the major event area.

**6 Major event period for Townsville 400—Act, s 12**

For section 12(2)(c) of the Act, the following periods are prescribed as the major event period for the Townsville 400—

- (a) from midday on 28 August 2020 to midday on 31 August 2020;
- (b) from midday on 4 September 2020 to midday on 7 September 2020.

**7 Carrying out temporary works for Townsville 400—Act, s 16**

For section 16(2) of the Act, the following periods are prescribed—

- (a) from the beginning of the day on 3 August 2020 to midday on 28 August 2020;
- (b) from midday on 31 August 2020 to midday on 4 September 2020;
- (c) from midday on 7 September 2020 to midnight on 18 September 2020.

**8 Declaration of official title for Townsville 400—Act, s 51**

For section 51(1)(b) of the Act, the title ‘2020 Townsville 400’ is declared an official title for the Townsville 400.

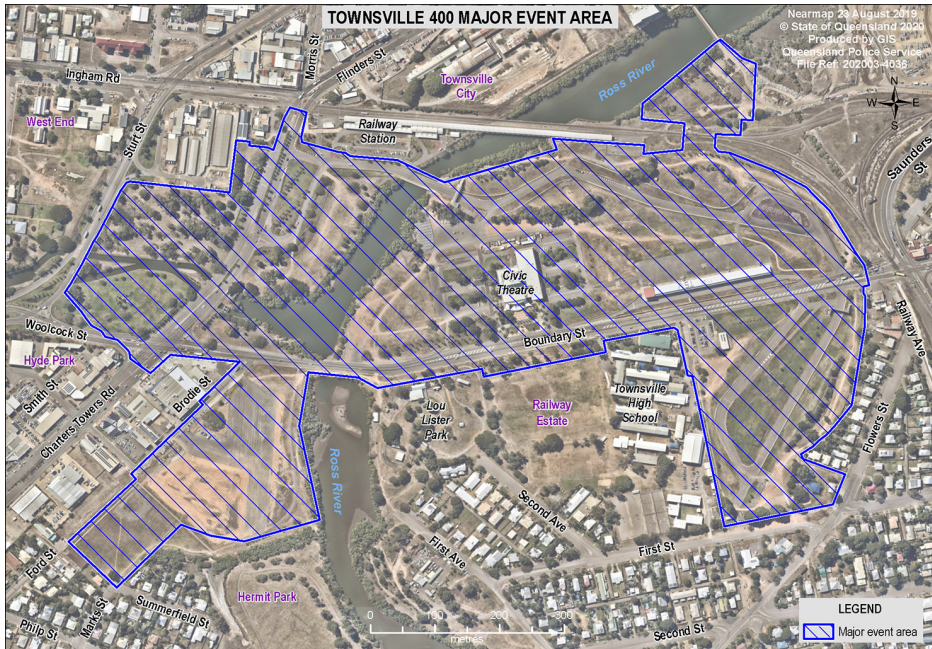
