Part 1 Preliminary

1 Short title

This regulation may be cited as the *Forestry (State Forests) and Other Legislation Amendment Regulation (No. 2) 2023*.

2 Purpose of revocation of forest reserve

For the *Nature Conservation Act 1992*, section 70E(3), the purpose of the revocation of the dedication of Beerwah Forest Reserve under section 6 is to allow the forest reserve to become a protected area.
