### 1 Short title

This notice may be cited as the Safety in Recreational Water Activities (Code of Practice) Amendment Notice 2024.

### 2 Commencement

This notice commences on 1 August 2024.

### 3 Notice amended

This notice amends the Safety in Recreational Water Activities (Code of Practice) Notice 2022.

### 4A Revocation of approved code of practice

If the entry in schedule 1A for an approved code of practice states that the code of practice has been revoked by a ministerial instrument stated in the entry—

- (a) the code of practice was revoked by the ministerial instrument stated in the entry;
   and
- (b) the inclusion of the revocation in schedule 1A is notice for the purposes of section 43(2) of the Act that the ministerial instrument stated in the entry revoking the code of practice has been made by the Minister.
