1 Short title

This regulation may be cited as the *Waste Reduction and Recycling Amendment Regulation 2024*.

This regulation amends the *Waste Reduction and Recycling Regulation 2023*.

- (b) for the financial year starting on 1 July 2024—the amount stated in schedule 5, column 3 opposite the local government;
- (c) for the financial year starting on 1 July 2025—the amount stated in schedule 5, column 4 opposite the local government;
- (d) for the financial year starting on 1 July 2026—the amount stated in schedule 5, column 5 opposite the local government.
