(a) to provide for the restructuring of the dairy industry, in accordance with proposals originating from the industry itself, in order to—	7 8 9
(i) establish a proper basis for the efficient management and operation of the industry; and	10 11
(ii) ensure the provision of high quality dairy produce in sufficient quantities to meet public demand; and	12 13
(b) to establish the Queensland Dairy Authority to administer the industry; and	14 15
(c) to establish the Queensland Dairy Industry Policy Council as a representative body to advise on policy issues; and	16 17
(d) to provide for the partial deregulation of the dairy industry without, however, prejudicing the maintenance of proper quality standards.	18 19 20

PART 2—POLICY AND ADMINISTRATION 20

Division 1—The Queensland Dairy Industry Policy Council 21

Establishment of the Council 22

Clause 5. The Queensland Dairy Industry Policy Council is established. 23

Functions of the Council	1
<i>Clause 6.</i> The functions of the Council are—	2
(a) to address, and advise on, the long-term strategic issues facing the dairy industry and to develop appropriate responses; and	3 4
(b) to assess and determine the characteristics of a sustainable dairy industry in Queensland for the medium and long term, and to formulate appropriate strategies for developing those characteristics; and	5 6 7 8
(c) to negotiate and encourage the developments required for the maintenance of a sustainable dairy industry in Queensland; and	9 10
(d) to report and make recommendations to the Minister and the Authority on issues concerning the dairy industry, either on the Council's own initiative or at the request of the Minister or the Authority; and	11 12 13 14
(e) to report and make recommendations to the Minister on the implementation and operation of this Act, and on progress towards achieving its objectives, and to review and monitor the Authority's strategic plan; and	15 16 17 18
(f) to determine, and convey to the Minister, industry views on price fixing, the vesting of milk, market milk access and the terms and conditions of processors' licences; and	19 20 21
(g) to carry out the other functions assigned to the Council under this Act.	22 23
Composition of the Council	24
<i>Clause 7.(1)</i> The Council is to consist of—	25
(a) the Minister or the Minister's nominee (who is to be chairperson of the Council); and	26 27
(b) the other persons that the Minister considers necessary and appropriate to represent adequately all sectors of the dairy industry and appoints to membership of the Council.	28 29 30
(2) The conditions on which members of the Council hold office are to be as determined by the Minister.	31 32

<i>Clause 8.(1)</i> The Council is to meet as necessary for the transaction of its business.	2 3
(2) The Minister may call the Council together to consider matters that the Minister desires to place before it.	4 5

<i>Clause 9.</i> The Council is to have a secretary and the other staff that are necessary to enable it to carry out its statutory responsibilities properly.	9 10

Establishment of Authority	17
<i>Clause 11.(1)</i> The Queensland Dairy Authority is established.	18
(2) The Authority—	19
(a) is a body corporate; and	20
(b) has a seal; and	21
(c) may sue and be sued in its corporate name.	22
(3) Judicial notice must be taken of the imprint of the Authority’s seal appearing on a document and the document must be presumed to have been properly sealed unless the contrary is proved.	23 24 25

Division 3—Functions and powers of the Authority**Functions of the Authority****Clause 12.** The functions of the Authority are—

- (a) to administer this Act subject to the Minister’s overriding power of direction and, in particular, to supervise and facilitate the restructuring of the dairy industry for which this Act provides; and
- (b) to take any action necessary to ensure that an adequate supply of dairy produce of high quality is available to meet all reasonable requirements throughout the State; and
- (c) to administer a supply management system in relation to market milk; and
- (d) to establish, and ensure compliance with, appropriate standards for the dairy industry and for dairy produce; and
- (e) to regulate the production, processing, transportation, distribution and sale of dairy produce to the extent contemplated by this Act; and
- (f) to promote and encourage the use of dairy produce; and
- (g) to conduct or support research or educational programs relevant to the objects of this Act; and
- (h) to carry out the other functions assigned to the Authority under this Act.

General powers of the Authority**Clause 13.(1)** The Authority has, for or in connection with the performance of its functions, all the powers of a natural person, and may, for example—

- (a) enter into contracts; and
- (b) acquire, hold, deal with and dispose of property; and
- (c) appoint agents and attorneys; and
- (d) make charges for services provided by it.

(2) The Authority may, by written notice, require a person who carries on a business in or associated with the dairy industry to provide specified returns or information that the Authority reasonably requires for the administration or enforcement of the Act.

(3) A person must not fail, without reasonable excuse, to comply with a requirement under subsection (2).

Maximum penalty—40 penalty units.

(4) It is a reasonable excuse for the person to fail to comply with the requirement if complying with the requirement may tend to incriminate the person.

Delegation

Clause 14.(1) The Authority may delegate any of its powers to—

- (a) a committee formed by the Authority; or
- (b) a member of the Authority; or
- (c) a member of the Authority's staff.

(2) The Authority may only delegate powers if satisfied that the committee to which, or the person to whom, the delegation is proposed has the expertise and experience necessary for the proper exercise of the powers.

Duty of consultation

Clause 15. The Authority must consult with the Council about the exercise of powers and functions that raise questions of industry policy.

Ministerial direction

Clause 16.(1) The Minister may direct the Authority in relation to the performance of its statutory functions and the exercise of its statutory powers.

(2) If the Minister gives a direction to the Authority—

- (a) the direction must be given in writing and must state the date on which it is to take effect; and

- (b) the direction must be published in the Gazette as soon as practicable after it is given; and 1

 - (c) the direction must be tabled in the Legislative Assembly within 14 sitting days after it is given; and 3
4
 - (d) the text of the direction is to be included in the annual report for the year in which the direction is given. 5

Division 4—Membership of the Authority 7

Composition of the Authority 8

Clause 17.(1) The Authority is to consist of the following members— 9

- (a) the chairperson; 10
- (b) 3 persons with experience in milk production, processing or distribution, nominated for appointment by a selection committee; 11
12
- (c) 3 persons with experience in public administration, business, finance, marketing, quality assurance or industrial relations, nominated for appointment by a selection committee. 13

(2) The chairperson and other members of the Authority are to be appointed by the Governor in Council. 16
17

(3) The Governor in Council may appoint a person to act as a member of the Authority during any period, or all periods, when the member is absent or unable for any reason to perform the duties of the office. 18
19

Selection of appointed members 21

Clause 18.(1) Before appointments of members (other than the chairperson) of the Authority are made, the Minister must establish a selection committee to nominate those members. 22
23
24

(2) The selection committee is to consist of 7 members appointed by the Minister, comprising— 25
26

- (a) 1 (the chairperson) who is, in the opinion of the Minister, suited by temperament and experience to act as an independent chairperson of the selection committee; and 27
28

-
- (b) 2 representatives of producers chosen by the Minister from nominations submitted, at the Minister's invitation, by organisations that are, in the Minister's opinion, representative of producers; and
- (c) 2 representatives of processors chosen by the Minister from nominations submitted, at the Minister's invitation, by organisations that are, in the Minister's opinion, representative of processors; and
- (d) 2 representatives of distributors chosen by the Minister from nominations submitted, at the Minister's invitation, by organisations that are, in the Minister's opinion, representative of distributors.
- (3) The Minister may give the selection committee written directions about the procedures and criteria to be adopted or applied in selecting nominees for appointment to the Authority, and the time within which the nominations are to be made.
- (4) A direction may not require the committee to nominate a specified person for appointment as a member of the Authority.
- (5) A member of the Council, a member of the selection committee, or a person who is chairperson, deputy chairperson or chief executive officer of an organisation established to represent producers, processors or distributors is not eligible to be nominated for appointment as a member of the Authority.
- (6) If the selection committee fails to make a nomination or to follow the procedures or apply the criteria of selection directed by the Minister, the Minister may nominate a person for appointment.
- (7) A nomination made by the Minister under subsection (6) is taken to have been made by the selection committee.
- (8) The chairperson of the selection committee is to be paid the fees and allowances that the Governor in Council may determine.

Term of office

- Clause 19.(1)** A member of the Authority is to be appointed for a term of not more than 3 years.

- (2) The office of a member of the Authority becomes vacant if the member—
- (a) dies; or
 - (b) completes a term of office and is not reappointed; or
 - (c) resigns by written notice to the Minister; or
 - (d) is absent, without leave of the Authority, from 3 consecutive meetings of the Authority; or
 - (e) becomes bankrupt; or
 - (f) becomes a patient within the meaning of the *Mental Health Act 1974*; or
 - (g) is removed from office by the Governor in Council.

Fees and allowances

Clause 20. The members of the Authority are entitled to the fees and allowances that may be determined by the Governor in Council.

Division 5—Proceedings of the Authority

Time and place of meetings

Clause 21.(1) Meetings of the Authority are to be held at the times and places that the Authority determines.

(2) However, the chairperson—

- (a) may at any time convene a meeting; and
- (b) must convene a meeting when requested by at least 3 members of the Authority.

Procedures governing transaction of business

Clause 22.(1) The chairperson or, in the absence of the chairperson, a member chosen to preside by the members present, is to preside at a meeting of the Authority.

- (2) At a meeting of the Authority— 1
- (a) 4 members constitute a quorum; and 2
 - (b) a question is to be decided by a majority of votes of members present and voting; and 3

 - (c) each member present has 1 vote on any question arising for decision and, if the votes are equal, the member presiding at the meeting has a casting vote. 5

- (3) The Authority may regulate its proceedings as it considers appropriate. 8

- (4) The Authority may permit members to participate in a particular meeting, or all meetings, by— 10
11
- (a) telephone; or 12
 - (b) closed circuit television; or 13
 - (c) any other means of communication. 14
- (5) A member who participates in a meeting of the Authority by permission under subsection (4) is taken to be present at that meeting. 15
16
- (6) If— 17
- (a) all members of the Authority agree in writing to a proposed resolution of the Authority; and 18
19
 - (b) notice of the proposed resolution was given in accordance with procedures approved by the Authority; 20
21
- the resolution is a valid resolution of the Authority, even though it was not passed at a meeting of the Authority. 22
23
- (7) The Authority may invite a person to attend a meeting of the Authority for the purpose of advising or informing it on any matter. 24
25
- Disclosure of interest** 26
- Clause 23.*(1) If— 27
- (a) a member of the Authority has a direct or indirect pecuniary interest in a matter being considered, or about to be considered, by the Authority; and 28
29

- (b) the interest could conflict with the proper performance of the member's duties in relation to the consideration of the matter; 1
2
- the member must, as soon as practicable after the relevant facts come to the member's knowledge, disclose the nature of the interest to a meeting of the Authority. 3
4

- (2) A disclosure under subsection (1) must be recorded in the Authority's minutes and, unless the Authority otherwise determines, the member must not— 6
7

- (a) be present during any deliberations of the Authority in relation to the matter; or 9
10
- (b) take part in any decision of the Authority in relation to the matter. 11
- (3) A member who has a direct or indirect pecuniary interest in the matter to which a disclosure under subsection (1) relates must not— 12

- (a) be present at any deliberation by the Authority for the purpose of making a determination under subsection (2); or 14
15
- (b) take part in the making by the Authority of a determination under subsection (2). 16
17

Minutes 18

Clause 24. The Authority must keep minutes of its proceedings. 19

Division 6—Committees 20

Committees 21

Clause 25.(1) The Authority may appoint committees for the purpose of advising the Authority on a particular subject or subjects. 22
23

(2) Regulations may be made governing the constitution, and regulating the proceedings, of a committee. 24
25

(3) A member of a committee is entitled to the fees and allowances that may be determined by the Authority. 26
27

Division 7—Staff of the Authority**Staff of the Authority**

Clause 26.(1) The Authority may employ, or engage the services of, such staff, consultants and contractors as are necessary for the administration and enforcement of this Act.

(2) The Authority must employ a general manager and a secretary (and those positions may be held in conjunction by the same person if the Authority considers appropriate).

(3) Subject to any relevant award or industrial agreement, the terms and conditions on which staff are employed are to be determined by the Authority.

Superannuation

Clause 27.(1) The Authority may contribute to, and participate in, a superannuation arrangement or scheme, approved by the Governor in Council, for the benefit of employees and former employees of the Authority and their dependants.

(2) An approval under subsection (1) may be absolute or conditional.

(3) The conditions of an approval under subsection (1) may, for example, authorise the Auditor-General to audit accounts and records relating to the approved arrangement or scheme.

Division 2—Vesting of milk

Evidentiary provision

Clause 113.(1) A certificate signed by a member or the secretary of the Authority to the effect that a person held or did not hold a licence of a particular class or an entitlement under this Act at a stated time or for a stated period is admissible in legal proceedings as evidence of that fact.

(2) The certificate of an analyst certifying the results of the analysis of a sample of dairy produce under this Act is admissible in legal proceedings as evidence of the results of the analysis.

Regulations

Clause 114.(1) The Governor in Council may make regulations for the purposes of this Act.

(2) Regulations may be made on any of the following subjects—

- (a) the qualifications required for authorised persons, analysts and other person engaged in the administration or enforcement of this Act;
- (b) the administration of the system of licences and entitlements under this Act;
- (c) the records to be kept and returns to be furnished by the holders of licences and entitlements under this Act;
- (d) the imposition of charges to be paid for the purposes of this Act;
- (e) offences for contravention of a regulation and the maximum penalties (which must not exceed 40 penalty units) for the offences.

PART 8—TRANSITIONAL PROVISIONS

Continuation of former Authority

Clause 115.(1) Until a date fixed by regulation (the “**transfer day**”), the Queensland Dairy Industry Authority constituted under the former Act is to continue in existence and is to exercise the powers and functions of the Authority under this Act (and references in this Act to the “**Authority**” are, where the context admits, to be interpreted accordingly).

(2) On the transfer day, the Queensland Dairy Industry Authority is dissolved and all its assets, rights and liabilities vest in the Authority constituted under this Act.

(3) This section expires at the end of the transfer day.

Legal proceedings

Clause 116.(1) Any legal proceeding by or against the Queensland Dairy Industry Authority that had not been completed before its dissolution may be continued and completed by or against the Authority constituted under this Act.

(2) This section expires at the end of the transfer day.

Existing staff

Clause 117.(1) Any person who held an office on the staff of the Queensland Dairy Industry Authority immediately before the transfer day is, on that day, transferred to a corresponding office on the staff of the Authority without prejudice to existing and accruing rights in respect of employment.

(2) This section expires at the end of the transfer day.

Superannuation arrangements and schemes

Clause 118.(1) A superannuation arrangement or scheme to which the Queensland Dairy Industry Authority was contributing at the commencement of this Act is taken to be an approved arrangement or scheme for the purposes of section 27.

(2) This section expires at the end of the transfer day.

Existing licences, permits and entitlements

Clause 119.(1) A licence in force under the former Act immediately before the commencement of this Act (other than a milkseller's licence) continues in force subject to this Act as if this Act had been in force when it was granted and it had been granted under this Act.

(2) A permit in force under section 61 of the former Act immediately before the commencement of this Act continues in force under this Act as if it were a licence granted on a temporary basis under section 39(3).

(3) An entitlement in force under section 77 of the former Act immediately before the commencement of this Act continues in force subject to this Act as if it were an entitlement under section 49.

(4) If the holder of a processor's licence held an authorisation under section 90 of the former Act immediately before the commencement of this Act, the processor's licence continues in force, subject to suspension or cancellation under this Act, until 31 December 1995 as if it were a licence conferring exclusive trading rights under section 42 in the same terms as the authorisation and then, subject to subsection (5), lapses.

(5) The Authority may, on the recommendation of the Council and with the approval of the Minister, renew a licence mentioned in subsection (4) from time to time on an annual basis from 31 December 1995.

(6) The terms and conditions of the licence, on its renewal, are to be as proposed by the Authority, recommended by the Council and approved by the Minister.

(7) Subsections (1) to (3) and this subsection expire at the end of the transfer day.

Existing orders etc.

Clause 120.(1) An order, direction or decision of the Queensland Dairy Industry Authority or of an inspector under the former Act is, if its effect is not exhausted at the commencement of this Act, subject to appeal under this Act in the same way as if it were an order, direction or decision of the Authority or an authorised person under this Act.

(2) This section expires at the end of the transfer day.

Existing regulations

Clause 121.(1) The regulations in force under the former Act immediately before the commencement of this Act remain in force, subject to amendment or repeal by a regulation under this Act, for the purposes of this Act and are to be read subject to the modifications that are necessary to make them consistent with this Act and adapt their operation to the provisions of this Act.

(2) The regulations mentioned in subsection (1) expire 6 months after the commencement of this Act unless earlier repealed.

(3) This section expires 6 months after the commencement of this Act.

PART 9—REPEAL**Repeal**

Clause 122. The *Dairy Industry Act 1989* is repealed.
