An Act to amend the Retail Shop Leases Act 1994

The Parliament of Queensland enacts—	1

Clause 1. This Act may be cited as the <i>Retail Shop Leases Amendment Act 1999</i> .	3

Retail Shop Leases Amendment

(6) Section 27— 1

insert— 2

‘(6) In this section— 3

“invalid review”, of rent under the lease, means— 4

(a) a review in a year of the lease, other than the first year, in which 5
the rent is to be reviewed under the lease more than once; or 6

(b) a review made under the lease using more than 1 basis. 7

“year”, of the lease, means a period of 12 months starting on— 8

(a) the day the lease is entered into; or 9

(b) an anniversary of the day the lease was entered into; or 10

(c) if, for a particular 12 month period, there is not an anniversary of 11
the day the lease was entered into—the last day of the month 12
corresponding to the month the lease was entered into.¹ 13

Replacement of s 91 (Parties to pay own costs) 14

‘Costs 17

‘91.(1) This section applies to the costs of the tribunal’s hearing of a 18
retail tenancy dispute. 19

‘(2) Unless the tribunal makes an order for costs under subsection (3), 20
each party to the dispute must bear the party’s own costs. 21

‘(3) On application by a party, the tribunal may make an order for costs 22
if it is satisfied— 23

(a) the dispute is frivolous or vexatious; or 24

(b) the party has incurred costs because another party— 25

- (i) sought an adjournment of the hearing without giving reasonable notice; or 1

- (ii) contravened a procedural requirement. 3

‘(4) If a party files, in a registry of the District Court, a document certified by the chief executive to be a true copy of an order for costs, the document may be enforced as an order of the District Court. 4

‘(5) If the tribunal makes an order for costs that does not state the amount of the costs, the amount must be decided under the *District Courts Rules 1968* as if the order were an order of the District Court and the hearing were conducted in the District Court.’. 7

‘Non-application of certain amendments of s 27 in certain cases 14

‘124. Section 27, as in force immediately before the commencement of the *Retail Shop Leases Amendment Act 1999*, continues to apply to a retail shop lease entered into before the commencement, and any extension or renewal of the lease, as if that Act had not commenced.’. 15
