**The Parliament of Queensland enacts—** 1

**PART 1—PRELIMINARY** 2

**Clause 1 Short title** 3

This Act may be cited as the *Primary Industries Legislation Amendment Act 2002*. 4

**Clause 2 Commencement** 6

Sections 14 and 21(2) commence on a day to be fixed by proclamation. 7
