## PART 2—APPLICATION OF ACT

### 4 Application of Act

Subject to section 5, this Act applies to any civil claim for damages for harm.

### 5 Civil liability excluded from Act

This Act does not apply in relation to any civil claim for damages for personal injury if the harm resulting from the breach of duty owed to the claimant is or includes—

- (a) an injury as defined under the *WorkCover Queensland Act 1996*, other than an injury to which section 36(1)(c) or 37<sup>1</sup> of that Act applies; or

*Example for paragraph (a)—*

A worker employed under a contract of service with a labour hire company is injured at the premises of a host employer while driving a defective machine. The worker pursues claims for damages for civil liability against the labour hire company, the host employer and the manufacturer of the machine. The worker suffers a number of injuries but only 1 of them is accepted as an injury under the *WorkCover Queensland Act 1996*, section 34. This Act does not apply to any of the claims for damages.

- (b) an injury that is a dust-related condition; or
- (c) an injury resulting from smoking or other use of tobacco products or exposure to tobacco smoke.

### 6 Act binds all persons

This Act binds all persons including the State and, to the extent the legislative power of the Parliament permits, the Commonwealth and the other States.

**CHAPTER 2—CIVIL LIABILITY FOR PERSONAL INJURY AND PARTICULAR DAMAGE TO PROPERTY, AND RELATING TO ECONOMIC LOSS** 1

**PART 1—BREACH OF DUTY** 4

*Division 1—General standard of care* 5

**9 General principles** 6

(1) A person does not breach a duty to take precautions against a risk of harm unless— 7  
8

- (a) the risk was foreseeable (that is, it is a risk of which the person knew or ought reasonably to have known); and 9  
10
- (b) the risk was not insignificant; and 11
- (c) in the circumstances, a reasonable person in the position of the person would have taken the precautions. 12  
13

(2) In deciding whether a reasonable person would have taken precautions against a risk of harm, the court is to consider the following (among other relevant things)— 14  
15  
16

- (a) the probability that the harm would occur if care were not taken; 17
- (b) the likely seriousness of the harm; 18
- (c) the burden of taking precautions to avoid the risk of harm; 19
- (d) the social utility of the activity that creates the risk of harm. 20

**10 Other principles** 21

In a proceeding relating to liability for breach of duty— 22

- (a) the burden of taking precautions to avoid a risk of harm includes the burden of taking precautions to avoid similar risks of harm for which the person may be responsible; and 23  
24  
25
- (b) the fact that a risk of harm could have been avoided by doing something in a different way does not of itself give rise to or affect liability for the way in which the thing was done; and 26  
27  
28

- (c) the subsequent taking of action that would (had the action been taken earlier) have avoided a risk of harm does not of itself give rise to or affect liability in relation to the risk and does not of itself constitute an admission of liability in connection with the risk.

### *Division 2—Causation*

## **11 General principles**

(1) A decision that a breach of duty caused particular harm comprises the following elements—

- (a) the breach of duty was a necessary condition of the occurrence of the harm (“**factual causation**”);
- (b) it is appropriate for the scope of the liability of the person in breach to extend to the harm so caused (“**scope of liability**”).

(2) In deciding in an exceptional case, in accordance with established principles, whether a breach of duty—being a breach of duty that is established but which can not be established as satisfying subsection (1)(a)—should be accepted as satisfying subsection (1)(a), the court is to consider (among other relevant things) whether or not and why responsibility for the harm should be imposed on the party in breach.

(3) If it is relevant to deciding factual causation to decide what the person who suffered harm would have done if the person who was in breach of the duty had not been so in breach—

- (a) the matter is to be decided subjectively in the light of all relevant circumstances, subject to paragraph (b); and
- (b) any statement made by the person after suffering the harm about what he or she would have done is inadmissible except to the extent (if any) that the statement is against his or her interest.

(4) For the purpose of deciding the scope of liability, the court is to consider (among other relevant things) whether or not and why responsibility for the harm should be imposed on the party who was in breach of the duty.

**12 Onus of proof**

1

In deciding liability for breach of a duty, the plaintiff always bears the onus of proving, on the balance of probabilities, any fact relevant to the issue of causation.

***Division 3—Assumption of risk***

5

**13 Meaning of “obvious risk”**

6

(1) For this division, an “**obvious risk**” to a person who suffers harm is a risk that, in the circumstances, would have been obvious to a reasonable person in the position of that person.

7

(2) Obvious risks include risks that are patent or a matter of common knowledge.

10

11

(3) A risk of something occurring can be an obvious risk even though it has a low probability of occurring.

12

(4) A risk can be an obvious risk even if the risk (or a condition or circumstance that gives rise to the risk) is not prominent, conspicuous or physically observable.

14

(5) To remove any doubt, it is declared that a risk from a thing, including a living thing, is not an obvious risk if the risk is created because of a failure on the part of a person to properly operate, maintain, replace, prepare or care for the thing, unless the failure itself is an obvious risk.

*Examples for subsection (5)—*

21

1. A motorised go-cart that appears to be in good condition may create a risk to a user of the go-cart that is not an obvious risk if its frame has been damaged or cracked in a way that is not obvious.

2. A bungee cord that appears to be in good condition may create a risk to a user of the bungee cord that is not an obvious risk if it is used after the time the manufacturer of the bungee cord recommends its replacement or it is used in circumstances contrary to the manufacturer’s recommendation.

	(1) If, in an action for damages for breach of duty causing harm, a defence of voluntary assumption of risk <sup>3</sup> is raised by the defendant and the risk is an obvious risk, the plaintiff is taken to have been aware of the risk unless the plaintiff proves, on the balance of probabilities, that he or she was not aware of the risk.	2 3 4 5 6
	(2) For this section, a person is aware of a risk if the person is aware of the type or kind of risk, even if the person is not aware of the precise nature, extent or manner of occurrence of the risk.	7 8 9
<b>15</b>	<b>No proactive duty to warn of obvious risk</b>	10
	(1) A person (“ <b>defendant</b> ”) does not owe a duty to another person (“ <b>plaintiff</b> ”) to warn of an obvious risk to the plaintiff.	11 12
	(2) Subsection (1) does not apply if—	13
	(a) the plaintiff has requested advice or information about the risk from the defendant; or	14 15
	(b) the defendant is required by a written law to warn the plaintiff of the risk; or	16 17
	(c) the defendant is a professional, other than a doctor, and the risk is a risk of the death of or personal injury to the plaintiff from the provision of a professional service by the defendant.	18 19 20
	<i>Note—</i>	21

(3) This section does not operate to exclude liability in connection with a duty to warn of a risk. 1

*Division 4—Dangerous recreational activities* 3

**17 Application of div 4** 4

(1) This division applies only in relation to liability in negligence for harm to a person resulting from a dangerous recreational activity engaged in by the plaintiff. 5  
6  
7

(2) This division does not limit the operation of division 3<sup>4</sup> in relation to a recreational activity. 8  
9

**18 Definitions for div 4** 10

In this division— 11

“**dangerous recreational activity**” means an activity engaged in for enjoyment, relaxation or leisure that involves a significant degree of risk of physical harm to a person. 12  
13  
14

“**obvious risk**” has the same meaning as it has in division 3. 15

**19 No liability for personal injury suffered from obvious risks of dangerous recreational activities** 16  
17

(1) A person is not liable in negligence for harm suffered by another person as a result of the materialisation of an obvious risk of a dangerous recreational activity engaged in by the person suffering harm. 18  
19  
20

(2) This section applies whether or not the person suffering harm was aware of the risk. 21

	(1) A doctor does not breach a duty owed to a patient to warn of risk, before the patient undergoes any medical treatment (or at the time of being given medical advice) that will involve a risk of personal injury to the patient, unless the doctor at that time fails to give or arrange to be given to the patient the information about the risk—	6 7 8 9 10
	(a) that a reasonable person in the patient’s position would, in the circumstances, require to enable the person to make a reasonably informed decision about whether to undergo the treatment or follow the advice; and	11 12 13 14

<b>22</b>	<b>Standard of care for professionals</b>	27
	(1) A professional does not breach a duty arising from the provision of a professional service if it is established that the professional acted in a way that (at the time the service was provided) was widely accepted by peer professional opinion by a significant number of respected practitioners in the field as competent professional practice.	28 29 30 31 32

- (2) However, peer professional opinion can not be relied on for the purposes of this section if the court considers that the opinion is irrational or contrary to a written law. 1  
2  
3
- (3) The fact that there are differing peer professional opinions widely accepted by a significant number of respected practitioners in the field concerning a matter does not prevent any 1 or more (or all) of the opinions being relied on for the purposes of this section. 4  
5  
6  
7
- (4) Peer professional opinion does not have to be universally accepted to be considered widely accepted. 8  
9
- (5) This section does not apply to liability arising in connection with the giving of (or the failure to give) a warning, advice or other information in relation to the risk of harm to a person associated with the provision by a professional of a professional service. 10  
11  
12  
13

### *Division 6—Contributory negligence* 14

#### **23 Standard of care in relation to contributory negligence** 15

- (1) The principles that are applicable in deciding whether a person has breached a duty also apply in deciding whether the person who suffered harm has been guilty of contributory negligence in failing to take precautions against the risk of that harm. 16  
17  
18  
19
- (2) For that purpose— 20
- (a) the standard of care required of the person who suffered harm is that of a reasonable person in the position of that person; and 21  
22
- (b) the matter is to be decided on the basis of what that person knew or ought reasonably to have known at the time. 23  
24

#### **24 Contributory negligence can defeat claim** 25

In deciding the extent of a reduction in damages by reason of contributory negligence, a court may decide a reduction of 100% if the court considers it just and equitable to do so, with the result that the claim for damages is defeated. 26

## PART 4—STRUCTURED SETTLEMENTS

### 64 Definition for pt 4

In this part—

“**structured settlement**” means an agreement providing for the payment of all or part of an award of damages in the form of periodic payments funded by an annuity or other agreed means.

### 65 Court required to inform parties of proposed award

(1) The purpose of this section is to enable the court to give the parties to a proceeding a reasonable opportunity to negotiate a structured settlement.

(2) A court that decides to make an award for future loss (not including interest) of more than \$100 000 must first notify all the parties to the proceeding of the terms of the award it proposes to make.

(3) The notification must set out the amount of each component part of the proposed award.

### 66 Court may make consent order for structured settlement

A court may, on the application of the parties to a claim for personal injury damages, make an order approving of or in the terms of a structured settlement even though the payment of damages is not in the form of a lump sum award of damages.

### 67 Obligation of legal practitioners to provide advice

A lawyer engaged by a plaintiff must advise the plaintiff, in writing, about the following if the plaintiff proposes to negotiate a settlement of a claim for personal injury damages—

- (a) the availability of structured settlements;
- (b) the desirability of the plaintiff obtaining independent financial advice about structured settlements and lump sum settlements of the claim.
