(a) is conducted mainly to provide accommodation to persons who 10
are enrolled in courses that, under the *Social Security Act 1991* 11
(Cwlth), section 569B, are approved courses of education or 12
study for section 569A(b)¹ of that Act; and 13

(b) is of a type mentioned in the accreditation Act, section 4(1), (2) 14
or (3); and 15

(c) is not a service mentioned in the accreditation Act, 16
section 4(5)(e), (f) or (h). 17

‘(2) For subsection (1)(b), in deciding whether a service is of a type 18
mentioned in the accreditation Act, section 4(1), section 4(4) of that Act 19
applies.’. 20
