- (c) if the food was of a nature that required it to be handled in a particular way to remain safe to consume after it left the entity’s possession—that the entity informed the community organisation or the other entity of the handling requirements; and
- (d) if the food only remained safe to consume for a particular period of time after it left the entity’s possession—that the entity informed the community organisation or the other entity of the time limit.
- ‘38B Liability not excluded if insurance required**
- ‘This subdivision does not confer protection from liability on a food donor if the liability is a liability that is required under a written law of the State to be insured against.
- ‘38C Liability not excluded for motor accidents**
- ‘The protection from liability conferred on a food donor by this subdivision does not apply if the liability would, apart from this subdivision, be covered by a CTP insurance policy under the *Motor Accident Insurance Act 1994*, or be recoverable from the Nominal Defendant under that Act.
