‘5F Terms and conditions of agreement

- ‘Without limiting sections 5A to 5D, the terms and conditions
that may be the subject of an agreement or a decision of the
Minister may include the following—
- (a) terms and conditions that limit or prevent any
unnecessary or reasonably avoidable interference with
or damage to the land in the proposed declared area;
 - (b) terms and conditions that limit or prevent any
unnecessary or reasonably avoidable interference with
any activity that may be lawfully carried on in the
proposed declared area;
 - (c) terms and conditions providing for reimbursement of
proper costs or expenses that may be incurred by a local
government or public authority or other owner or
occupier of the land in the proposed declared area.

‘5G Certain Acts and laws not to apply

- ‘(1) The *Environmental Protection Act 1994* does not apply to or
in relation to any noise from the construction or other activity
authorised under this part.
- ‘(2) Except to the extent that the provisions of the *Local*
Government Act 1993, the *Building Act 1975*, the *Coastal*
Protection and Management Act 1995, the *Integrated*
Planning Act 1997 and the *Land Act 1994*, chapter 3, part 1
require compliance with prescribed standards, the provisions
do not apply to or in relation to the construction or other
activity authorised under this part.

‘5H Directions by Minister 4

- ‘(1) The Minister may give all directions necessary or convenient for the purpose of the exercise by the State or another entity of its powers under this part. 5

- ‘(2) An entity mentioned in subsection (1) given a direction under the subsection must comply with the direction and must not authorise any act or omission contrary to the direction.’. 8
