‘475C Issue of identity card to each authorised person

- ‘(1) The chief executive must issue an identity card to each authorised person.
- ‘(2) The identity card must—
- (a) contain a recent photo of the person; and
 - (b) contain a copy of the person’s signature; and
 - (c) identify the person as an authorised person under this Act for a waterway transport management plan; and
 - (d) state an expiry date for the card.
- ‘(3) This section does not prevent the issuing of a single identity card to a person for a waterway transport management plan and other purposes.

‘475D Production or display of identity card

- ‘(1) In exercising a power under this division in relation to a person, an authorised person must—
- (a) produce the authorised person’s identity card for the person’s inspection before exercising the power; or
 - (b) have the identity card displayed so that it is clearly visible to the person when exercising the power.
- ‘(2) However, if it is not practicable to comply with subsection (1), the authorised person must produce the identity card for the person’s inspection at the first reasonable opportunity.

‘(1) An authorised person may enter a place if— 13

(a) its occupier consents to the entry; or 14

(b) the entry is authorised by a warrant. 15

‘(2) For the purpose of asking the occupier of a place for consent to enter, an authorised person may, without the occupier’s consent or a warrant— 16

(a) enter land around premises at the place to an extent that is reasonable to contact the occupier; or 19

(b) enter part of the place the authorised person reasonably considers members of the public ordinarily are allowed to enter when they wish to contact the occupier. 21

‘475J Procedure for entry with consent’ 24

‘(1) This section applies if an authorised person intends to ask an occupier of a place to consent to the authorised person or another authorised person entering the place under section 475I(1)(a). 25

- ‘(2) Before asking for the consent, the authorised person must tell the occupier—
- (a) the purpose of the entry; and
 - (b) that the occupier is not required to consent.
- ‘(3) If the consent is given, the authorised person may ask the occupier to sign an acknowledgement of the consent.
- ‘(4) The acknowledgement must state—
- (a) the occupier has been told—
 - (i) the purpose of the entry; and
 - (ii) that the occupier is not required to consent; and
 - (b) the purpose of the entry; and
 - (c) the occupier gives the authorised person consent to enter the place and exercise powers under this division; and
 - (d) the time and date the consent was given.
- ‘(5) If the occupier signs the acknowledgement, the authorised person must immediately give a copy to the occupier.
- ‘(6) If—
- (a) an issue arises in a proceeding about whether the occupier consented to the entry; and
 - (b) an acknowledgement complying with subsection (4) for the entry is not produced in evidence;
- the onus of proof is on the person relying on the lawfulness of the entry to prove the occupier consented.

‘475K Application for warrant

- ‘(1) An authorised person may apply to a magistrate for a warrant relating to a place.
- ‘(2) The application must be sworn and state the grounds on which the warrant is sought.
- ‘(3) The magistrate may refuse to consider the application until the authorised person gives the magistrate all of the information

the magistrate requires about the application in the way the
magistrate requires. 1

application to be given by statutory declaration. 4

‘475L Issue of warrant 6

‘(1) A magistrate may issue a warrant only if the magistrate is
satisfied there are reasonable grounds for suspecting— 7

(a) there is a particular thing or activity (the *evidence*) that
may provide evidence of an offence against a waterway
transport management plan; and 9

(b) the evidence is at the place or, within the next 7 days,
may be at the place. 12

- ‘(2) Before entering the place the authorised person must do, or make a reasonable attempt to do, the following—
- (a) identify himself or herself to a person who appears to be an occupier of the place by producing a copy of the authorised person’s identity card;
 - (b) give the person a copy of the warrant;
 - (c) tell the person the authorised person is permitted by the warrant to enter the place;
 - (d) give the person an opportunity to allow the authorised person immediate entry to the place without using force.
- ‘(3) However, the authorised person need not comply with subsection (2) if the authorised person reasonably believes that immediate entry to the place is required to ensure the effective execution of the warrant is not frustrated.
- ‘(4) Subsection (2)(a) does not apply to an authorised person who is a police officer.

‘Subdivision 3 Powers after entry 20

‘475N General powers after entering places 21

- ‘(1) This subdivision applies to an authorised person who enters a place under subdivision 2. 22

- ‘(2) However if, under section 475I(2), the authorised person enters a place to ask the occupier’s consent to enter a place, this subdivision applies to the authorised person only if the consent is given or the entry is otherwise authorised. 24

‘475O Power to require reasonable help or information 27
