*relevant development approval condition* means condition 42 of the relevant development approval, a copy of which is set out in schedule 1A.

**‘30AJ Application of div 1** 4

This division applies to major sport events held between 1 January 2011 and 31 December 2011 at the major sports facility called ‘Suncorp Stadium’.

**‘30AK Major sport events between 1 January 2011 and 31 December 2011** 8

‘(1) Subject to compliance with the conditions of the relevant development approval, other than the relevant development approval condition, the use of Suncorp Stadium for no more than 24 major sport events between 1 January 2011 and 31 December 2011 is a lawful use of the facility. 10

‘(2) Subsection (1) applies despite the relevant development approval condition, the *Sustainable Planning Act 2009*, any provision of the relevant planning scheme, any development approval or compliance permit under that Act relating to the facility and any condition attached to the approval or permit. 15

42	As referred to in Section 3.4 of the <i>Lang Park Stadium Redevelopment Assessment Report</i> by The Coordinator General dated August 2000 and in Section 2.6 of <i>Volume 1 Executive Summary - Draft Environmental Impact Statement</i> by Sinclair Knight Merz dated May 2000, there are to be no more than 24 major events (crowd size exceeding 25000 persons) per annum.
