(1) The main purpose of this Act is to deliver the best possible management of the Gold Coast waterways at reasonable cost to the community and government, while keeping government regulation to a minimum.	12 13 14 15
(2) Other purposes of this Act are to do the following—	16
(a) plan for and facilitate the development of the Gold Coast waterways over the long term in a way that is sustainable and considers the impact of development on the environment;	17 18 19 20
(b) improve and maintain navigational access to the Gold Coast waterways;	21 22
(c) develop and improve public marine facilities relating to the Gold Coast waterways;	23 24
(d) promote and manage the sustainable use of the Gold Coast waterways for marine industries, tourism and recreation.	25 26 27

- (3) To achieve the purposes, this Act establishes the Gold Coast Waterways Authority to strategically plan for, facilitate and manage the development and use of the Gold Coast waterways.

4 Relationship with other Acts

- (1) This Act does not affect the operation of the following Acts—
- (a) the *Fisheries Act 1994*;
 - (b) the *Marine Parks Act 2004*;
 - (c) the *Maritime Safety Queensland Act 2002*;
 - (d) the *Transport Infrastructure Act 1994*;
 - (e) the *Transport Operations (Marine Pollution) Act 1995*;
 - (f) the *Transport Operations (Marine Safety) Act 1994*.
- (2) This Act does not affect the functions or obligations of a local government under the following laws—
- (a) the *Coastal Protection and Management Act 1995*;
 - (b) the *Local Government Act 2009* or a local law made under that Act;
 - (c) the *Sustainable Planning Act 2009*.

5 Act binds all persons

- (1) This Act binds all persons including the State and, to the extent the legislative power of the Parliament permits, the Commonwealth and the other States.
- (2) Nothing in this Act makes the State liable to be prosecuted for an offence.

- (e) a reference in a contract to a named State entity is a reference to the State.
