308 Existing directions to cease unsafe work 1

- (1) This section applies if, before the 2
commencement, a health and safety 3
representative directed a worker to cease work 4
under former section 85. 5
- (2) Former section 85 continues to apply in relation 6
to the direction as if the section had not been 7
repealed by the amendment Act. 8

309 Entry to workplace under former s 119 9

- (1) This section applies if— 10
- (a) before the commencement, a WHS entry 11
permit holder entered a workplace under 12
part 7, division 2; and 13
- (b) at the commencement, the WHS permit 14
holder has not given notice of the entry and 15
the suspected contravention under former 16
section 119. 17
- (2) Former section 119 continues to apply in relation 18
to the entry as if the amendment Act had not been 19
enacted. 20
