**7.42C Ending of proceeding—subject officer does 8  
not give consent for new prescribed officer to 9  
conduct proceeding 10**

- (1) This section applies if the subject officer does not 11  
give the commissioner, within the stated period 12  
under section 7.42B(1) or the longer period the 13  
commissioner allows, written consent to appoint a 14  
new prescribed officer to conduct the disciplinary 15  
proceeding. 16

- (2) The commissioner must appoint another 17  
prescribed officer to start a disciplinary 18  
proceeding under division 3 or 4 against the 19  
subject officer for the complaint (the *new* 20  
*proceeding*). 21

- (3) The prescribed officer appointed under 25
