81A What are *economic reasons for termination* 28

The following are *economic reasons for* 29

-
- termination* of a community titles scheme— 1
- (a) if all of the lots included in the scheme are 2
used for a commercial purpose—that it is 3
not economically viable for the scheme to 4
continue; 5
- (b) that, on the day a pre-termination report is 6
given to lot owners, or within 5 years from 7
that day, it is not, or will not be, 8
economically viable for the body corporate 9
for the scheme to carry out repairs and 10
maintenance to any property or assets the 11
body corporate must maintain in good or 12
structurally sound condition. 13

81B What is a *termination plan* 14

- (1) A *termination plan* is a document prepared by a 15
body corporate for a community titles scheme that 16
sets out the following matters for the termination 17
of the scheme— 18
- (a) the arrangements necessary to ensure the 19
sale of the scheme to a single entity, 20
including, if known— 21
- (i) the name of the entity that is proposing 22
to buy the scheme; and 23
- (ii) the proposed sale price; and 24
- (iii) the proposed day for settlement of the 25
contract; and 26
- (iv) if the scheme is to be sold by public 27
auction or tender— 28
- (A) the proposal for marketing the 29
sale of the scheme; and 30
- (B) the minimum reserve price for the 31
sale or details of the way in which 32

- A** is the amount to which a person would be entitled if, at the time the scheme is sold, the scheme land were compulsorily acquired under the *Acquisition of Land Act 1967*.
- D** is the amount of any debt the person owes to the body corporate.

- respective market value of a lot principle** is the principle that the market value of a lot in a community titles scheme is the value expressed as a percentage of the sum of the market value of all of the lots in the scheme.

to pass a termination resolution. 31

**81J Giving termination plan before general 24
meeting 25**

A body corporate for a community titles scheme 26
must give each lot owner a copy of the 27
termination plan for the scheme at least 120 days 28
before it holds a general meeting to consider a 29
motion for a termination resolution. 30

- (1) This section applies if a body corporate for a community titles scheme passes an economic reasons resolution and complies with section 81J. 3

 - (2) The body corporate may call a general meeting to consider a motion for a termination resolution. 6

 - (3) The general meeting must not consider any other motion proposing an alternative way to terminate the scheme. 8

 - (4) A motion for a termination resolution may only be passed if 75% or more of all lot owners vote for the motion. 11

 - (5) One vote only may be exercised for each lot included in the scheme. 14

 - (6) A vote can not be exercised by proxy. 16
 - (7) If the regulation module applying to the scheme provides for a motion to be decided by secret ballot, the motion must be decided by secret ballot. 17

 - (8) Also, despite anything in the regulation module applying to the scheme, an owner of a lot may vote on the motion if the owner owes a body corporate debt in relation to the lot at the time of the meeting. 21
