## **NATURE CONSERVATION (FOREST RESERVES) REGULATION 2000**

[as amended by all amendments that commenced on or before 8 August 2003]

### **1 Short title**

This regulation may be cited as the *Nature Conservation (Forest Reserves) Regulation 2000*.

### **2 Dedication of forest reserves**

(1) Each area of State forest, timber reserve or Land Act reserve described in the schedule is dedicated as a forest reserve.

(2) Each forest reserve is given the name stated opposite its description in the schedule.

### **3 Inspection of forest reserve plans**

The plans mentioned in the schedule are available for inspection by members of the public during office hours on business days at—

- (a) the department's head office;<sup>1</sup> and
- (b) each regional office of the department in whose area the forest reserve is situated.
