# Nature Conservation (Forest Reserves) Regulation 2000

[as amended by all amendments that commenced on or before 22 November 2013]

## 1 Short title

This regulation may be cited as the *Nature Conservation (Forest Reserves) Regulation 2000*.

## 2 Dedication of forest reserves

- (1) Each area of Land Act reserve, State forest, timber reserve or unallocated State land described in the schedule is dedicated as a forest reserve.
- (2) Each forest reserve is given the name stated opposite its description in the schedule.

## 3 Inspection of forest reserve plans

The plans mentioned in the schedule are available for inspection by members of the public during office hours on business days at—

- (a) the department's head office; and

- (b) each regional office of the department in whose area the forest reserve is situated.
