# Foreign Ownership of Land Register Regulation 2013

[as amended by all amendments that commenced on or before 1 July 2014]

## **1 Short title**

This regulation may be cited as the *Foreign Ownership of Land Register Regulation 2013*.

## **2 Commencement**

This regulation commences on 1 September 2013.

## **3 Fees**

The fees payable under the Act are stated in schedule 1.

## **4 Repeal**

The Foreign Ownership of Land Register Regulation 2003, SL No. 178 is repealed.
