General Outline

Short title

This regulation may be cited as the Transport Legislation (Fees) Amendment Regulation 2017.

Policy objectives and the reasons for them

This regulation will introduce a variety of departmental fees and charges for the 2017-18 financial year.

Each year the Department of Transport and Main Roads (the department) undertakes a review of fees and charges. The review adjusts general fees and charges based on Queensland Government policy, which states that fees and charges are to be increased annually by the current Government indexation policy.

The current Government indexation policy was confirmed on 18 February 2017 to be 3.5 per cent.

Queensland Treasury requires State Government fees and charges to be indexed annually. No consultation has been undertaken with external stakeholders.
