1 Short title

This regulation may be cited as the *Regional Planning Interests Amendment Regulation (No. 1) 2016*.

2 Commencement

This regulation commences on 1 July 2016.

3 Regulation amended

This regulation amends the *Regional Planning Interests Regulation 2014*.

- (e) for land in the Wet Tropics zone—\$20,700.
